

GENERAL ORDINANCE # 5

WABASH COUNTY, INDIANA.

WHEREAS, the Board of County Commissioners of Wabash County, Indiana, have on the 7th day of March, 1966, adopted a comprehensive Master Plan and Zoning Ordinance for the Town of North Manchester, Indiana, and,

WHEREAS, pursuant to Ch. 174, § 34 of the Acts of Indiana, 1947, as amended, said Ordinance automatically operates as a zoning ordinance up to the boundaries of the Town of North Manchester, Indiana, and,

WHEREAS, the Plan Commission of the Town of North Manchester, Indiana, has heretofore filed its petition with the Board of County Commissioners requesting that it be permitted the authority to exercise planning and zoning jurisdiction outside its boundaries and area contiguous to the Town of North Manchester, Indiana, and,

WHEREAS, the Wabash County Plan Commission, pursuant to notice duly given did on the 17th day of November, 1965, hold a public meeting to consider the merits of said petition and have made their recommendations to the Board of County Commissioners of Wabash County, Indiana, and,

WHEREAS, the Board of County Commissioners of Wabash County, Indiana, have carefully considered the recommendations made by the Plan Commission and have made their own study and inquiry into the matter,

NOW, THEREFORE, BE IT ORDAINED AS FOLLOWS:

The Board of County Commissioners of Wabash County, Indiana, this 2^d day of May, 1966, do hereby grant to the Plan Commission of the Town of North Manchester, Indiana, the exclusive rights, powers and duties to exercise planning

and zoning jurisdiction in the following described area outside the corporate limits of the Town of North Manchester, Indiana, the same being bounded and described as follows, to-wit:

BEGINNING at the southwest corner of Section numbered one (1) in Township twenty-nine (29), Range six (6) east; thence north along the west line thereof to the northwest corner of said Section numbered one (1); thence east to the southeast corner of Section numbered thirty-five (35) in Township thirty (30) north, Range Six (6) east; thence north to the northwest corner of Section numbered twenty-five (25) in Township thirty (30) north, Range six (6) east; thence east to the northeast corner of said Section numbered twenty-five (25); thence north to the northwest corner of Section numbered thirty (30) in Township thirty (30) north, Range seven (7) east; thence east to the northeast corner of Section numbered twenty-eight (28) in Township thirty (30) North, Range 7 East; thence south to the southeast corner of Section numbered thirty-three (33) in Township thirty (30) North, Range seven (7) east; thence west to the northeast corner of Section numbered four (4) in Township twenty-nine (29) North, Range seven (7) east; thence south to the southeast corner of said Section numbered four (4); thence west to the southwest corner of Section numbered six (6) in Township 29 North, Range seven (7) east; thence south to the southeast corner of said Section numbered one (1) in Township twenty nine (29) North, Range six (6) east; thence west to the place of beginning.

This Ordinance in the rights, powers and duties conferred thereupon shall be effective as of the date of passage of the Wabash County Master Plan and Zoning Ordinance.
