ORDINANCE CHANGING THE BOUNDARIES  
AND CHANGING THE NUMBER OF PRECINCTS  
FROM EIGHT TO TEN IN NOBLE TOWNSHIP  
IN WABASH COUNTY, INDIANA.

WHEREAS, the County Commissioners of the several counties of the state shall have the sole and exclusive right and power to create election precincts, and define their boundaries in their respective counties and in the cities and towns located therein, pursuant to the Acts of 1945, Ch. 208, S 78, and,

WHEREAS, the County Commissioners of each of the several counties of this state in which any city is located, shall, on or before the first day of March of each year, meet and rearrange the several voting precincts of such county in such a manner that boundaries of the several voting precincts of such county in such city shall be coextensive with the boundaries of such city, should the boundaries of the city have been changed during the preceding twelve (12) months, pursuant to Acts, 1945, Ch. 208, S 79.

NOW THEREFORE, BE IT ORDAINED by the County Commissioners of Wabash County, Indiana that:

1. The number of precincts in Noble Township, Wabash County, Indiana shall be increased from eight in number to ten in number.

2. The previous precincts for Noble Township, Wabash County, Indiana are hereby changed, altered, and superseded, except that Precinct #6 remains unchanged and that former precinct #7 has been changed to Precinct #9 and former Precinct #8 has been changed to Precinct #10.

3. The ten precincts in Noble Township, Wabash County, Indiana, hereby created, hereby retained unchanged, or hereby retained and renumbered shall be bounded and described as follows:

## PRECINCT #1, Noble Township, Wabash County, Indiana

BEGINNING at the intersection of the west city limits line with Pike Street, thence northward and following the City Limits line to the Wabash River; thence eastward up said river to the west line of Reserve #17; thence southward and following the west line of Reserve #17 (the same being the east City line) to the Cassett Road; thence westward along the Cassett Road to Lafontaine Avenue; thence westward along Lafontaine Avenue to Columbus Street; thence westward along Columbus Street to Vernon Street; thence southward along Vernon Street to Pike Street; thence westward along Pike Street to the place of beginning.

## PRECINCT #2

BEGINNING at the intersection of the west City Limits line with the Wabash River, thence northward and following the City Limits line to Mill Street; thence eastward along Mill Street to Hill Street; thence eastward and northward along Hill Street (Lageo Road) to the east City Limits line; thence southward and following the City Limits Line to the Wabash River; thence westward down said river to the place of beginning.

## PRECINCT #3

BEGINNING at the intersection of Huntington Street with Hill Street, thence northward along Huntington Street to Manchester Avenue; thence northward along Manchester Avenue to the North City Limits line; thence eastward and southward and following the City Limits line to Hill Street (Lagro Road); thence southward and westward along Hill Street to the place of beginning.

PRECINCT #5

BEGINNING at the intersection of Stitt Street (U.S. Road #24) with the west City Limits line, thence eastward along Stitt Street to Cass Street; thence southward along Cass Street to Ferry Street; thence westward along Ferry Street to Carroll Street; thence southward along Carroll Street to Hill Street; thence westward along Hill Street to Mill Street; thence westward along Mill Street to the west City Limits line; thence northward and following the City Limits line to the place of beginning.

PRECINCT #6

BEGINNING AT the intersection of Harrison Avenue with Alber Street, thence northward along Alber Street to the north City Limits Line; thence eastward and following the City Limits line to Manchester Avenue (State Road #13); thence southward along Manchester Avenue to Harrison; thence westward along Harrison Avenue to the place of beginning.

PRECINCT #7

BEGINNING at the intersection of Pike Street with the west City Limits line, thence eastward along Pike Street to Vernon Street; thence northward along Vernon Street to Columbus Street; thence eastward along Columbus Street to Lafontaine Avenue; thence continuing eastward along Lafontaine Avenue to the Cassett Road; thence continuing eastward along the Cassett Road to east City Limits line; thence southward and following the City Limits line to the south City Limits line; thence westward and following the west City Limits line; thence northward and following the City Limits line to the place of beginning.

PRECINCT #8

BEGINNING at the intersection of Stitt Street and Cass Street, thence westward along Stitt Street to the west City Limits line; thence northward and following the City Limits line to the north City Limits line; thence eastward and following the City Limits line to Alber Street; thence southward along Alber Street to Cass Street; thence southward along Cass Street to the place of beginning.

PRECINCT #9

BEING that area in Noble Township north of the Wabash River and outside the City Limits of the City of Wabash, Indiana.

PRECINCT #10

BEING that area in Noble Township south of the Wabash River and outside the City Limits of the City of Wabash Indiana.
