THREE DISTRICTS IN METHOPOLITAN SCHOOL DISTRICT OF WABASH COUNTY, INDIANA.

WHEREAS, The Metropolitan School District of Wabash County has been created yethe consolidation of Lagro School Township, Liberty School Township, Paw Paw School ownship, Waltz School Township, and Noble School Township;

AND WHEREAS, this Board of Commissioners is required to divide the territory f said Metropolitan School District into three(3) districts which are approximately qual in population;

NOW THEREFORE, be it ordained:

- 1. That District One (1) of Metropolitan School District of Wabash County, ndiana, shall include,
 - (a) All of Paw Paw Township of Wabash County,
 - (b) All of Noble Township outside of the City of Wabash EXCEPT the following part:

Beginning at the intersection of State Highway Number Fifteen(15) and the south line of Noble Township; running thence northwesterly and north with said State Highway Number 15 to the south boundary line of the City of Wabash; thence eastwardly, northwardly and westwardly, (following at all points the corporate limits of the City of Wabash) to State Highway Number Thirteen(13); thence northeastwardly with said Highway Thirteen (13) to its intersection with the east line of Noble Township (which is also the

Range line between ranges 6 and 7 East); thence south, and eastward followin at all points the east line of Noble Township, to the southeastcorner of Noble Township; thence west along the south line of Noble Township to State Highway Fifteen (15), (the place of beginning).

- 2. That District Two(2) of Metropolitan School District of Wabash County, Indiana shall include,
 - (a) All of Lagro Township of Wabash County,
 - (b) That part of Noble Township of Wabash County, bounded and described as follows:

Beginning at the intersection of State Highway Number Fifteen (15) and the south line of Noble Township; running thence northwesterly and north with said State Highway Number Fifteen (15) to the south boundary line of the City of Wabash; thence eastwardly, northwardly and westwardly, (following at all points the corporate limits of the City of Wabash) to State Highway Number Thirteen (13); thence northeastwardly with said Highway Number Thirteen (13) to its intersection with the east line of Noble Township (which is also the Range line between Ranges 6 and 7 East thence south, and eastward following at all points the east line of Noble Township, to the southeast corner of Noble Township; thence west along the south line of Noble Township to State Highway Fifteen (15) (the place of beginning).

3. That District Three (3) of Metropolitan School District of Wabash County, Indiana, shall include all of Waltz Township and all of Liberty Township, of Wabash County, Indiana.
