ORDINANCE # 2022-85-12

AN ORDINANCE VACATING PARTS OF OLD SLOCUM TRAIL FROM COUNTY ROAD SOUTH 600 WEST TO COUNTY ROAD SOUTH 700 WEST, COUNTY ROAD SOUTH 700 WEST FROM COUNTY ROAD WEST 700 SOUTH TO COUNTY ROAD WEST 800 SOUTH, AND COUNTY ROAD WEST 800 SOUTH FROM COUNTY ROAD SOUTH 650 WEST TO COUNTY ROAD SOUTH 700 WEST

The Wabash County Highway Department has filed its petition to vacate parts of certain county roads ("Roadways"), more particularly described as follows:

- (a) Old Slocum Trail from County Road South 600 West to County Road South 700 West;
- (b) County Road South 700 West from County Road West 700 South to County Road West 800 South; and
- (c) County Road West 800 South from County Road South 650 West to County Road South 700 West.

The Board of Commissioners, being duly advised, now finds as follows:

1. The Roadways are susceptible to flooding.
2. The Roadways are no longer necessary to operate the County's highway system.
3. It is no longer reasonable or practical for the County to continue to expend monies for repair and maintenance of the Roadways.
4. Vacating the Roadways in the public interest and the economic interest of the County.
5. Vacating the Roadways will not unreasonably interfere with the flow of traffic on the County's highway system.



6. The names and addresses of all owners and lessees of land that abut those parts of the Roadways are as follows:

and written notice of a public hearing on the Department's petition was sent via certified mail to such owners and lessees at least ten (10) days prior to this date, as required by law.

7. Notice of a public hearing was published at least ten (10) days prior to this date, as required by law, and on this date a public hearing was held at which time all interested persons were heard.

8. The Department's petition should be granted.

NOW, THEREFORE, BE IT ORDAINED THAT:

1. The following Roadways:


- a. Old Slocum Trail from County Road South 600 West to County Road South 700 West,
- b. County Road South 700 West from County Road West 700 South to County Road West 800 South, and
- c. County Road West 800 South from County Road South 650 West to County Road South 700 West,

are now vacated.


2. The Auditor shall furnish a copy of this Ordinance to the County Recorder for recording.


