

**COUNCIL RESOLUTION #4, 1996
FINDING WITH RESPECT TO STATEMENT
OF BENEFITS OF DEXTER AXLE
(DIVISION OF TOMKINS INDUSTRIES)**

WHEREAS, DEXTER AXLE (DIVISION OF TOMKINS INDUSTRIES) has filed with the County Council of Wabash County, Indiana, its Statement Of Benefits in connection with the installation of new manufacturing equipment in its industrial plant located on the real estate located in Wabash County, Indiana, described on Exhibit "A" attached hereto and made a part hereof;

WHEREAS, the County Council of Wabash County, Indiana, having reviewed the Statement Of Benefits of Dexter Axle (Division of Tomkins Industries) and being satisfactorily advised with respect thereto, now finds:

1. The estimate of the value of the new manufacturing equipment is reasonable for equipment of that type.
2. The estimate of the number of individuals who will be employed or who will be retained can be reasonably expected to result from the proposed installation of the new manufacturing equipment.
3. The estimate of the annual salaries of those individuals who will be employed or whose employment will be retained can be reasonably expected to result from the proposed installation of new manufacturing equipment.
4. Any other benefits about which information was requested are benefits that can be reasonably expected to result from the proposed installation of new manufacturing equipment.
5. The totality of benefits is sufficient to justify the deduction.
6. The deduction for the new manufacturing equipment is allowed for a period of five years.
