## LR43-AR-8 Kosciusko County Drug Problem Solving Court Fees

Those persons directed to participate participating in the a Kosciusko County Drug Problem Solving Court may be assessed fees in accordance with the following SCHEDULE OF FEES, pursuant to the authority granted by Indiana Code 33-23-16-23:

- 1. A <u>Drug Problem Solving</u> Court administration fee of \$100.00 due one time upon admission to a Problem Solving Court <del>per participant payable to the Kosciusko County Community Corrections Department</del>.
- 2. A <u>Drug Problem Solving</u> Court user fee of \$50.00 per month for every month that an individual participates in a <u>Drug Problem Solving</u> Court, beginning with the second month of participation. It is payable to the <u>Kosciusko County Community Corrections Department.</u>
- 3. A Drug Problem Solving Court transfer fee of \$25.00 per participant per transfer, payable to the Kosciusko County Community Corrections Department.
