➤ **Practice of Law**

When I was in private practice, I handled a variety of civil litigation files at the trial court level, including banking, commercial sales, product liability, as well as auto accidents and premises liability, and some at the appellate court level. I drafted the briefs in almost all appeals and complex cases handled by the law firm, including wrongful death, a Clean Water Act claim, and complicated insurance coverage issues.

5. Trial/Judicial Experience

- I second chaired several jury trials with my dad, Jerry Huelat, who is an outstanding litigator. The last jury trial that we tried together before I became a judge was a traumatic brain injury case in March 2020 in Porter County with Judge Bradford. In February 2015, we tried a wrongful death case in February 2015 in Lake County with Judge Parent where we represented a driver who was intoxicated. Prior to that, I second chaired portions of jury trials with my dad, including a UIM auto accident case in Porter County in February 2014.
- Additionally, I have been attending my dad's trials since I was probably 12 years old. The first one was a criminal jury trial for child molestation that he tried as a Deputy Prosecutor in the LaPorte Circuit Court. That is where I discovered my love of courtrooms and jury trials. I attended at least 20 to 30 of them over the years and learned a lot. This provided me with a strong foundation for understanding trial practice, which has served me well on the trial court bench.

B. Describe the extent of your bench trial experience, if any.

- In 2017, I tried a dog vs. dog mauling case in LaPorte Superior Court No. 3 in front of Judge Thorne. I represented the Plaintiff owners of the terrier who was mauled by a pit bull mix. It was a defense verdict.
- I tried a breach of warranty/damage to real property case in LaPorte Superior Court No. 4 in front of Judge Friedman against a real estate developer. My clients were a national door and window manufacturer and a Midwest big box store. We received a defense verdict plus attorney fees.
- I tried another real estate property damage case in Porter Superior Court No. 4 with Judge Chidester. My client was a brick installation company that was alleged to have damaged the real property during the brick installation. We received a defense verdict.
- The first bench trial that I tried was a damage to personal property case in LaPorte Superior Court No. 4 in front of Senior Judge Don Harner. My client was a real estate developer that was sued for the condition of a parking lot causing damage to a vehicle. The Plaintiff obtained a verdict against my client.

- In November of 2020, I was elected Judge of the LaPorte Superior Court No. 1 after defeating the incumbent. This court's docket includes major felonies, civil litigation, family law, mental health, paternity, adoptions, collections, post-conviction relief, probate, and protective orders. I also have been the special judge on all other case types that I do not generally handle, including misdemeanors, small claims, child in need of services (CHINS) cases, and termination of parental rights. The only kind of case that I have not handled is juvenile delinquency.

Because of the variety of cases on the Superior No. 1 docket, I have heard and decided a wide range of issues from federal and state Constitutional issues involving suppression of confessions, statements, and evidence to custody issues that depend upon the best interest of the child, from consent issues for adoption to testamentary capacity and undue influence, from writs for habeas corpus to separation of powers issues. This has provided me with a broad base of experience and has prepared me for the breadth of cases that the Indiana Court of Appeals handles.

- Since taking the bench on January 1, 2021, I have presided over many criminal jury trials and a several criminal and civil bench trials. I will never forget the first jury trial. It was a ten count tragic case, including two counts of dealing resulting in death, which involved a careful determination of what evidence was permitted under the exceptions to the prior bad acts exclusion. Some of the other cases involved unlawful possession of a firearm by a serious violent felon, burglary, possession of and dealing in controlled substances, another dealing resulting in death, and a few murders.
- I served as a pro tem for Judge Kathleen Lang, LaPorte Superior Court No. 1, from 2012 to 2014. During that time, I conducted probable cause and initial hearings, ruled on requests made by probation, and reviewed filings and issued orders on various civil matters, including protective orders.

➤ **Dealing Resulting in Death**

The first jury trial over which I presided was a dealing resulting in two deaths case. It was a sad case in which the deceased victims were the girlfriend and the friend of the Defendant. The victims’ families and the Defendant were devastated. It was an emotionally charged case with complicated evidentiary issues involving prior bad acts, opportunity, common plan or scheme, and joint acquisition. There were no reported cases on this relatively new crime, so there was no case law to follow in deciding these evidentiary issues with respect to the kinds of facts involved in this particular crime. Instead, consideration was given to other cases addressing prior bad acts.

➤ **Double Murder**

In July of 2023, I presided over a double murder jury trial where the Defendant, who has mental health issues, was found guilty by the jury and convicted of murdering his father and his uncle by brutally stabbing them multiple times to death. The father lived for several days before he passed away and was able to tell the police what happened. His aunt was on the phone with his uncle at the time of the murder and testified about what she heard. The legal issues involved, among others, the admissibility of the father’s statement to police and the aunt’s testimony about what she heard, including the uncle’s statement about the nephew being the perpetrator. It was a tragic case that I do not think that I will ever forget.

➤ **Mass Tort Litigation**

When I was in private practice, my law firm was involved in mass tort litigation when it was defending a company that was sued in the Indiana State Fair stage collapse litigation, which involved multiple deaths and many personal injuries, including loss of limbs, brain injuries, paralysis, etc. This litigation was so large that all the attorneys in the firm were involved in different aspects of the case. My contribution to this case involved attending select depositions and drafting all the major motions and briefs for our client. The most important briefs were a Motion for Consolidation and a Motion for Summary Judgment (Tab 5).

The Motion for Consolidation was successful in ultimately consolidating at least ten separate cases for discovery purposes so that our client did not have to defend in ten different courts at the same time.

The scope of this case and the sheer number of litigants and attorneys involved in it made it a once in a career kind of case, at least for a small firm. The case itself was important in shedding light on why the tragedy occurred so that changes could be made industry wide, outdoor concerts could be made safer, and the victims of the tragedy be compensated.

➤ **Excessive Verdict**

My dad and I tried a wrongful death case together in February 2015 where we represented the drunk driver who caused the Plaintiff's death while driving extremely intoxicated after being overserved at a restaurant and a bar. Despite our best efforts and due to factors that were beyond our control, the verdict against all of the Defendants was tens of millions of dollars. We were at least able to convince the jury to place half of the fault on the bar and restaurant and saved our client millions of dollars.

I drafted the Joint Motion to Correct Errors (see Tab 8) based upon the excessiveness of the verdict, which was denied. I, then, appealed the verdict and drafted the Appellant's Brief for our client. This appellate brief helped to convince the Plaintiff that it would be in its best interest to settle the claim rather than continue with the appellate process. After much negotiation, the case was settled, which was a blessing for all the parties.

➤ **Termination of Guardianship of a Child – Inspiring the Next Generation**

I presided over a case in which a child was under a guardianship, because her mother had a substance abuse problem. Her grandmother was her guardian. Her mother worked very hard to get clean and sober and to turn her life around. Grandmother agreed to terminate the guardianship. The child was a young, impressionable girl, and she was fascinated with the courtroom and, I think, the fact that she saw a woman on the bench. After the hearing, she asked some questions about my favorite color and superhero. She then asked if she could come up on the bench and give me a hug. Her eyes were wide as she approached me at the bench and was taking it all in. Her family laughed as she went back to them, and we commented to each other that I may have inspired the next generation. This is one of my goals – to inspire the next generation of lawyers and judges.

I was honored to be appointed by Chief Justice Rush to serve as an at-large member of the Judicial Conference Board of Directors. This board directs the activities of the judicial conference, whose purpose is, among others, to promote an exchange of experience and suggestions for the judicial system, continuing education, and a better understanding of the judiciary.

• **Indiana Innovation Initiative** – 2019-Present

I received an appointment from the Indiana Supreme Court to serve on the Indiana Innovation Initiative. We are tasked with the responsibility of vetting innovations to increase the efficiency and decrease the cost of the judicial system, as well as make it easier to navigate, all while ensuring that justice is fairly administered and rights are protected. We make recommendations to the Indiana Supreme Court about pilot projects, rule and procedural changes, and other innovations. At this point, we have recommended that the Indiana Supreme Court accept the Family Law Taskforce and the Technology Working Group's recommendations. Based upon these recommendations, pilot projects are ongoing.

• **Civil Litigation Taskforce** – 2021-2022

As a member of the Indiana Innovation Initiative, I volunteered to serve on the Civil Litigation Taskforce. I was appointed Chair of the Service of Process Subcommittee. As Chair, in addition to running our meetings, I examined cases from around the country about alternate modes of service and drafted a portion of the Taskforce report on this issue. Our focus was on ensuring that Due Process is met, people actually receive notice, and decreasing costs. In addition to service of process, the Taskforce made recommendations for improvements in alternative dispute resolution, case management, discovery, and technology.

➤ **2024 Spring Judicial College – Illuminating Your Well-Being CLE/CJE**

I served on a panel for a CLE/CJE session on judicial well-being. This session focused on causes of judicial stress and burnout and ways to reduce them. I talked about my experience in The Inner Work of Judging, a fairly intensive program that I took part in with four other trial court judges and magistrates, and how I was able to reduce my stress to become more effective.

• **ISBA Board of Governors** – 2016-2018

I was selected to serve on the ISBA’s Board of Governors as the District 2 Representative. This opportunity provided me with the ability to influence how the largest bar association in the state improves the law, the legal system, and the administration of justice. I was a part of the process for hiring the new Executive Director, involved in talks about how to preserve the practice of law and the profession, as well as protect the citizens of Indiana, from the unauthorized practice of law and impermissible fee sharing, and whether to support the recommendations of the Indiana Bar Examination Assessment Task Force. I thoroughly enjoyed sitting on the board and continuing the mission of the ISBA in serving both the legal community and the public.

• **Litigation Section Chair** – 2018-2019

During my time as Chair, I offered suggestions for changes and updates to the ISBA Juror’s Handbook. Also, often based upon my advice, we offered input on several bills in the Legislature to the ISBA Legislative Counsel on topics related to attorneys and the practice of law, including judgment dockets, Sheriff’s service of process fee, tax appeals, and interest on judgments.

• **Litigation Section CLE Subcommittee Member** – 2018 & 2019

The Litigation Section holds a legal education Symposium each year. In 2018, we were asked by President Andi Metzel to help with the Litigation Track for the ISBA Annual Meeting, as well. I helped to plan both events, and I was the Co-chair of the Annual Meeting Litigation Track sub-subcommittee. With the help of several other committees and sections, we put together a program addressing topics and issues that were relevant to litigators.

In 2018-2019, I was the Chair of this Subcommittee. I led the planning of the 5th Annual Litigation Symposium, which was advanced legal writing. I also helped plan the Annual Meeting CLE for the professional development track, which focused on law firm culture, expectations for associates, work-life balance, client development, marketing strategies, and law practice management in each size firm, as well as discussing ethical issues that can arise, particularly during transition from one firm to another.

- **ISBA Legal Education Conclave – “Bridging the Gaps: Connecting with Communities and Their Leaders to Improve Understanding and Access to Justice”** – 2018

In 2018, the ISBA held a Legal Education Conclave, which was an invitation only event. I attended this meeting of lawyers, judges, and law professors. During this conclave, we talked about implicit bias, access to justice issues, racism, mental health and substance abuse issues, and problem solving courts. Because of this meeting, I recognized the need for a mental health and young adult court in LaPorte County. LaPorte Circuit Court has since started a juvenile mental health court and Superior 4 is working on starting one for adults. I would like to develop a young adult court, since Superior 1 has so many young people who could benefit from some extra help and support to keep them out of the criminal courts.

- **ISBA Law Student Conclave** – 2018

The ISBA hosted a Law Student Conclave to bring Indiana law students from around the state together for networking, competition, and to work on building legal skills. I was a brief grader for the Moot Court Competition and offered guidance and constructive comments on the students’ appellate briefs to help mold our future appellate practitioners.

- **ISBA Panel for Valparaiso University Law School** – 2014 & 2017

The ISBA travels to the law schools every year to speak to the students about becoming involved in bar associations. I spoke on the panel as a representative of the Leadership Development Academy, all the sections and committees of which I am a member, and all the bar associations with which I am involved.

- **ISBA Legal Education Conclave – “The Future of Legal Education and the Profession”** – 2015

This was also an invitation only event that I attended. During this conclave, we talked about the changing landscape of the legal profession, the potential threats to it, access to justice, diversity, wellness issues, the issues with decreased enrollment at law schools, inability for recent graduates to find jobs, and skyrocketing law student debt. There was a call for volunteers to come up with some solutions to these problems. I volunteered to be on the committee, but I do not believe that one was ever assembled by the ISBA.

Indiana Legal Services revived its Appellate Pro Bono Project in 2017. This project connects the indigent with attorney panel members who provide civil pro bono appellate representation. I was a member of this panel but was not called upon to represent anyone.

- **Amicus Committee**

The DTCI Amicus Committee receives requests for DTCI amicus participation from attorneys around the state who are involved in appeals, and it makes recommendations to the Board of Directors about issues to be addressed or potential positions to be taken. When I went on the Board of Directors,

I expressed an interest in serving on this committee. The committee was full, but my willingness to be involved prompted a change in the structure of the committee and terms have now been assigned to the members on the committee.

While I had many opportunities as a Board member to influence whether an amicus brief was written and what position the organization would take, I wanted to have more direct involvement with the briefs and their drafting. I was voted in as a member, and my term began in 2016 and ended in 2020. We had received approximately forty amicus requests during that time. As part of the process, I would read the briefs, orders, and opinions issued in each case and then offer recommendations on whether DTCL should participate. I drafted an Amicus Brief on a Petition to Transfer in 2017.

➤ **Women Lawyers Association**

• **Domestic Violence CLE Committee** – 2016

The Women Lawyers Association worked with Judge Hawkins, Lake Superior Court No. 2, to put on a CLE during October, which is Domestic Violence month. As a member of this committee, I worked with the Chair, Magistrate Raduenz, on coordinating with the court, organizing the luncheon, and informing our members.

• **Jurors as Judges IV CLE Committee** – 2016

This is another CLE in which the Women Lawyers Association collaborated with Judge Hawkins. In addition to being a member of the committee, I was the co-moderator. We asked real jurors about their experiences serving on their respective juries, what the attorneys did well, and what they thought could be improved upon in the jury system. This CLE was an eye-opening seminar that allowed litigators hear firsthand what jurors think and how they feel about what we do during trial, including what is effective and what is not.

• **Court of Appeals on Wheels Oral Argument Committee** – 2014

We brought the Court of Appeals to the Lake County Courthouse in Crown Point in April 2014 for an oral argument. The committee arranged for many high schools from Lake and Porter Counties to be present at the argument. It also arranged for them to have legal definitions about the legal process and terms related to the case. I created a placard for the sponsors and assisted at the event and during the reception for the court.

- **Jurors as Judges II Committee** – 2014

Judge Hawkins, Lake Superior Court No. 2, invited the WLA to help him with this CLE program, as well. I attended the meeting with Judge Hawkins and several committee members, attempted to help find some jurors from LaPorte County, and helped with the event.

- **Professional Development Panel for Valparaiso University Law School's Professional Development Day** – 2014 & 2015

Valparaiso University Law School put on a couple of programs each year for its students to meet lawyers in the community and connect with various bar associations. It was a wonderful opportunity to help these students network and to mentor them during their law school experience.

- **Law Day Committee Member** – 2016-2019

As a member of the Law Day Committee, I helped plan the Law Day ceremonies. I created the programs each year, and I secured Professor Derrick Carter to speak about *Miranda* in 2016 and Professor Rosalie Berger Levinson to speak about the 14th Amendment in 2017. Members of the public were invited, so we were educating the members of the bar and members of the public with these programs.

- **Law Day – “Magna Carta: Symbol of Freedom for All”** – 2015

As President of the LaPorte County Bar Association, one of my duties was to put together the Law Day event with the help of the Law Day Committee. The keynote speaker was Senior Judge Boklund, whose presentation was “When the Door to the Jury Room Closes”. We honored two of our members who passed away who were well-loved and respected members of our association and community. We, then, presented Officer Dion Campbell with the Liberty Bell Award for his service to the community, particularly for his work with the youth.

I also worked with a local middle school to get students involved. They submitted projects based on civil rights and equality for a contest that was judged by the committee. The winners presented their projects at the Law Day ceremony, and their whole class was in attendance. Their teacher, Tanya Roach, told me later that we may have inspired some future lawyers. We honored Ken Layton with the Liberty Bell Award for a lifetime of service to LaPorte County.

During law school and after until I had children, I participated in the VUSL Law Clinic Benefit. The students and law school staff performed a musical each year for the Law Clinic’s benefactors to raise funds for the operation of the law clinics, which serve the disadvantaged families of Porter County, and for a new clinic building. The new Heritage Hall was completed in 2010.

- **2019 Litigation Section Civility Award**

I honored with the Litigation Section’s Civility Award, which recognizes an attorney for outstanding civility and professionalism in their dealings with fellow judges, attorneys, parties, witnesses, and the public.

Through the Michigan City Exchange Club, elementary, middle school, and high school students come to court for a “Day in Court” during our Tuesday criminal call for the Initial Hearings, Bail Review Hearings, and hearings on Motions for Sentence Modification. After the hearings, I spend 15-30 minutes talking to the students and answering their questions. This is my favorite part of the week, because I have the honor of inspiring the next generation of lawyers and judges.

Most of the students write an essay about their “Day in Court”. The teachers select the best one from their class and submit them to the Michigan City Exchange Club. I select the best one, and the top essay authors are awarded by the Exchange Club during a luncheon. I was the keynote speaker for the luncheon in 2023 and 2024, during which I talked about the importance of civics education, how the Day in Court program teaches students about the legal system, what they learn, and how we can inspire them.

➤ **Indiana Kids' Election Speakers' Bureau – 2012 & 2020**

In 2020, I engaged virtually with the fifth graders at Westville Elementary School, and we talked about the federal election and electoral process, as well as the local elections. In 2012, I taught a gifted class at Joy Elementary School in Michigan City about the election process.

➤ **2018 Michiana Forty Under 40 Recipient**

This recognition from the South Bend Regional Chamber, the Young Professionals Network, and other entities in the Michiana area is based upon initiative and dedication in pursuing a career, proven success and achievement, and investment in and service to others through community involvement, along with a passion for community and giving back.

➤ **2017 Outstanding Young LaPortean**

In November of 2017, I was honored with this award from the LaPorte Chamber of Commerce and the LaPorte Jaycees for being one of two outstanding young LaPorteans. This award is given to those who excel in their career and who enhance the community through leadership and service.
