 - Judicial Conference Training (9/15/23)
 - o Reflection on the event
 - Judges found the training to be very helpful events like this should be on as many future agendas as possible
 - A lot of people are looking for specialized knowledge a session does not have to have 150+ people to be a success – there seems to be more interest in doing a good job at guardianship cases than would be reflected in audience numbers
 - Based on the training, some judges in the southwest portion of Indiana are going to touch base and take notes on local practice
 - Many local counties are using bench bar conferences or local bars for training
 - There was recently an event held in Allen County by the Northeast Indiana Guardianship Conference – agenda included in minutes
