Language in 34-26-5-10 regarding hearing timing:

Several forms/orders and the instructions on the PO website will need to be updated with new language to reflect the new statute. Magistrate Douglass will start on updating the forms.

Benchbook update:

Final changes were approved and will be updated. Then final language of the book will be forwarded for formatting and accessibility changes.

Forms in Odyssey update and question:

Petition with school language and lifetime registry changes will be done and forwarded to court technology for updating. The Protection Order Registry will be updated to match the language of Form NC-0102.

2023 Legislation:

There are currently three (3) bills related to protection orders and they will be followed by the committee. None have a hearing set at this time.

Explanation on the flow of paper for protection order:

Strategic planning flow chart on protection orders will be sent to committee. Since each county handles their protection order caseload differently, it would be difficult to delineate one best way to move protection orders through the system.

Senate Bill 161:

- Magistrate Douglass will start work on amending the forms to comply with the new statute.
- How to Improve Electronic Filing: Committee had a discussion on what improvements they would like to see with the electronic filing system:
- Quicker connectivity with INcite and Odyssey
- Better instructions for Petitioners
- Better information on the county systems
- Information with warnings on respondent information such as what would happen if they
 did not have enough information to locate respondent for service
- Need entire petitioner information

April minutes were approved.

Updates:

- New form for device tracking per new statute: Language was drafted by Magistrate
 Douglass. Language was approved by the committee and instructions need to be updated to
 include GPS language as well.
- 2. Juvenile NCO issues: The Committee received a number of questions from judges regarding the lack of a form for juvenile delinquency proceedings. The Committee discussed the need for a juvenile form and the ability to make it confidential. Magistrate McMath will work on the forms.
- Amending PO Forms to streamline the forms: As this is the last meeting for 3 members and 3 new members will be starting in October, this issue was tabled to the October in person meeting.
- 4. New Case: S.D. v. G.D.: Protection order case which was presented at oral argument before the Supreme Court in May. The Committee will be taking note when a decision is issued to see if there is a new standard created for the decisions on these cases.
- 5. Clerk's Conference on Protection Orders: Protection Orders updates will be a session at the Clerk's Conference during the week of 6/26/23. The Committee was asked if there were any issues they wanted addressed at the session and there were none. Expungements were discussed and a possible new form may be necessary to allow the original petitioner in the protection order to waive the hearing and agree to the expungement.

June Minutes are approved.

Firearm Surrender Procedures:

Discussion was had amongst the committee members regarding procedures for holding respondents accountable when the respondent fails to comply with the court ordered surrender of any firearms. Two different protocols were outlined by the committee. The first was to refer the situation to the county prosecutor's office for indirect criminal contempt proceedings. The second was to order respondent into court for an explanation as to why they had not surrendered the firearms as ordered. At that time, the situation can be managed by the court either with a warrant for failure to appear, a contempt order or compliance with the original order.

Updating and Streamlining of Forms:

With consultation from the clerks, records managers and the committee, the decision was made to take a large number of forms off of the publicly available website and to consolidate other forms. Specifically, the following orders will be removed from the website: PO-105, PO-109, PO-110, PO-113, PO-122, PO-129, PO-130, PO-132, PO-133, PO-134, PO-135 and PO-136.

Additionally, the following forms were determined to also be unnecessary to be on the website: PO-117, PO-118, PO-120 and PO-131. The entirety of the no contact order forms and CHPO forms will be removed as well as WV-106.

Further, forms PO-121, PO-124, PO-125, PO-127, that were necessary when protection orders were filed only on paper, were determined to be obsolete in the current protection order system and will be deleted from the website.
