NON-FINAL ORDER OF DISMISSAL

Respondent, the Indiana Department of Homeland Security, performed an inspection of Petitioner, Great Lakes Orthopedics & Sports Medicine, P.C., and issued an inspection report citing Petitioner for a violation of ASME A17.1. 8.6.11.1. Petitioner filed a petition for review of this violation. After the initiation of the appeal, Petitioner contacted the Administrative Law Judge and indicated that the petition for appeal was accidental and that Petitioner did not want to further pursue an appeal. Respondent had no objection to dismissing the appeal. See Exhibit A, which are various emails dated May 29, 2019 RE: In the Matter of Great Lakes Orthopedics & Sports Medicine, DHS 1905-FPBSC-005.

Accordingly, the Administrative Law Judge now enters this Non-Final Order of Dismissal. The ultimate authority in this matter is the Fire Prevention and Building Safety Commission (Commission). Indiana Code § 4-21.5-3-29(d) requires any party seeking to preserve an objection to this order for judicial review to file a written objection that

- 1. identifies the basis of the objection with reasonable particularity; and
- 2. is filed with the Commission within fifteen days (or any longer period set by statute) after this order is served.

In the absence of an objection from a party or notice from the Commission of its intent to review any issue related to this order, the Commission shall affirm this order in accordance with Indiana Code § 4-21.5-3-29(c). This order will be considered by the Commission on Tuesday, July 2, 2019, at 9:00 a.m. (EDT), in Conference Center Room B, Indiana Government Center South, 302 West Washington Street, Indianapolis, IN 46204.
