- Of course, the taxpayer can file an appeal and present additional evidence to consider if he/she disagrees with the assessed value determined.




## Water Tank House Mississippi River View





















# **Tiny Home, Jasper County**
















# **Cody Street Project**

- The Board of Public Works approved the contract between the city and the Community Action Program of Evansville for over a quarter of a million dollars. The money is helping fund the Cody Street Project. It's a plan to construct two affordable housing units near Cedar Hall School in Evansville on Cody Street.
- The two homes will be built from shipping containers, so they will be Evansville's first entry into the shipping container home building process.
- We are very excited about it. Number one because it adds two more homes to the affordable housing portfolio of the city. But, number two, we're big believers in innovation and trying everything to create more affordable living units for people." says Kelley Coures, Executive Director of the Department of Metropolitan Development.

# Manufactured Home Defined IC 9-3-2-96

• IC 9-13-2-96

Manufactured home

Sec. 96. (a) "Manufactured home" means, except as provided in subsections (b) and (c), a structure that:

- (1) is assembled in a factory;
- (2) Bears a seal certifying that it was built in compliance with the federal Manufactured Housing Construction and Safety Standards Law(42USC 5401 et seq.)
- (3) is designed to be transported from the factory to another site in one (1) or more units;
- (4) is suitable for use as a dwelling in any season; and
- (5) is more than thirty-five(35) feet long.

The term does not include a vehicle described in IC 9-13-2-150(2).




#### **Park Models**

 The "more than 35' length" requirement in the statutes makes some assessors question park models titled as an RV because the characteristics of it are more similar to a mobile/manufactured home than to a recreational vehicle, but the Bureau of Motor Vehicles (BMV) has the authority to title the recreational vehicles and the length is one of the statutory requirements that they consider when making a determination on the classification of the asset.

• The subject property is a single-family dwelling. This is a dome shaped dwelling of stucco construction. The topography of the land has the south and west sides built below grade.

#### 45-07-25-426-008.000-001:

 The subject properties are 2- unit apartments. These are Quonset hut style buildings of metal construction. There are 5 – 2- unit buildings which classifies this as commercial property.

45-11-29-476-019.000-035:

• The subject property is a single- family dwelling. This is a dome shaped dwelling of wood frame construction.




45-02-36-451-004.000-023:
