The Department of Natural Resources serves the DNR 30-Day Public Notice in order to satisfy the requirements of the "Procedures Concerning Certain Licenses Act", IC 14-11-4, and its associated administrative rule, 312 IAC 2-3.

The DNR 30-Day Public Notice is published weekly to serve notice of the latest permit applications received at the DNR, Division of Water. Petition for Public Hearing

A pre-action public hearing on an application may be requested by filing a written petition. For a petition to be considered valid it must:

1. contain the typed or legibly printed name and complete mailing address of each petitioner;
2. be signed by a minimum of 25 individuals who are at least 18 years old and either reside in the county where the project will take place or own real property within 1 mile of the project site;
3. affirm that each signatory to the petition satisfies the requirements of item 2; and
4. identify the application for which the public hearing is being requested either by the application # or the applicant's name and the project description.

A petition which does not meet these requirements will be considered invalid and the hearing request will not be granted. To request a pre-action public hearing, send the petition by email to water_inquiry@dnr.in.gov or by mail to:

Project Description: Approximately 200' to 230' of Cicero Creek's eroded north streambank will be stabilized with class 1 riprap to protect the bank from further erosion. The riprap will be keyed into the streambed at its base and will conform to the existing bank at the project limits. It will have a maximum height of 18'. It will not project streamward beyond the existing bank. It will have a 2:1 or lesser sideslope. Other work includes the removal and replacement of a toe anchor on an existing stormwater pipe, removing existing paved ditches, and cutting back a 6' pipe to match the new sideslope. **Project Location:** Beginning at the State Road 19 crossing and continuing downstream (east) for approximately 230' at Tipton

Project Description: A Newbury rock riffle will be constructed just downstream of a 16" waterline in the Eel River to provide structural integrity for the waterline. Approximately 3,000 tons of glacial boulders will be utilized to construct the riffle. The rock riffle, from the crest upstream and downstream, will be constructed with Class I glacial cobble (6-8" in diameter) mixed with approximately 50% of glacial boulders 4' long by 3' wide and 2' tall. A crest will be constructed about 20' downstream of the waterline and will be 1' above the elevation of the waterline. From the crest upstream, the rock material will extend back towards the line at a 4:1 slope. The downstream slope from the crest will be a maximum of 20:1, or a 5% slope, and extend 70' downstream of the crest. Each end of the line where it is currently buried will be covered with glacial cobble for an area of 50' by 15'. The areas covered on the ends are composed of a large gravel bar with no riparian vegetation. There will be no fill (stone) needed to access the stream from the left descending bank. This bank is currently grass and there is an old boat ramp made of asphalt that will serve as the entry point. The old boat ramp will be removed at the end of the project. The stream bank will be stabilized, and native trees will be planted. **Project Location:** The rock riffle will be located in Logansport Indiana on the Eel River at approximately river mile 1.5 near Logansport

Approximately 2 feet of accumulated muck and debris will be removed from the channel bed by dredging to a depth of 6.5 feet below the average normal level of the lake at the center of the channel and sloping uniformly to a depth of 5 feet at a distance of 5 feet from the seawalls. The excavated material will be transported to an upland containment area for dewatering and disposal. Water from the containment area will not be allowed to return to the lake. No tree clearing has been proposed.

Project Description: Dredging will take place near both the north and south dock locations to remove accumulated sediments along the property owner's 90-foot lakefrontage on Jimmerson Lake. Dredging will remain approximately five feet away from the shoreline and will go no further out than the end of the dock which is approximately 35 feet. These areas will be dredged to a maximum depth of six feet below the legal lake level with a maximum slope of 3:1 away from the shoreline. Dredging will be completed mechanically. An excavator will sit on barges and place spoils in totes on the barges. The dredge sediments will be disposed of at an upland area to dewater with no return to Jimmerson Lake or the adjacent wetlands. Dredge materials will be contained and transported in a vac truck to alleviate spillage on roadways and be moved to Reinhold's Gravel Pit, which has been previously approved.
