The Department of Natural Resources serves the DNR 30-Day Public Notice in order to satisfy the requirements of the "Procedures Concerning Certain Licenses Act", IC 14-11-4, and its associated administrative rule, 312 IAC 2-3.

The DNR 30-Day Public Notice is published weekly to serve notice of the latest permit applications received at the DNR, Division of Water. Petition for Public Hearing

A pre-action public hearing on an application may be requested by filing a written petition. For a petition to be considered valid it must:

1. contain the typed or legibly printed name and complete mailing address of each petitioner;
2. be signed by a minimum of 25 individuals who are at least 18 years old and either reside in the county where the project will take place or own real property within 1 mile of the project site;
3. affirm that each signatory to the petition satisfies the requirements of item 2; and
4. identify the application for which the public hearing is being requested either by the application # or the applicant's name and the project description.

A petition which does not meet these requirements will be considered invalid and the hearing request will not be granted. To request a pre-action public hearing, send the petition by email to water_inquiry@dnr.in.gov or by mail to:

Project Description: Two new bridges will be constructed over Evers Ditch to carry Pedestrians across the stream. The new structures will be single span removable aluminum bridge with span lengths of 48'. The structures will have an out-to-out length of approximately 60' and a clear walkway width of 8'. The abutments will be skewed to align with streamflow. The approach walks will be elevated a maximum of 2' above the existing grade. No temporary construction access crossing is planned within the right-of-way on the side of the proposed bridges.

Project Description: Improvements will be done on the existing earthen Indian Trail Lake Dam's (IDNR Dam #68-3) principal spillway. The concrete at the existing CMP inlet will be demolished and removed. Riprap at the CMP inlet and outlet will be removed. Also, the existing trash rack, metal pipe cover and supports will be removed. An 18" diameter HDPE pipe will be placed next to the existing 18" diameter CMP pipe. Once the pipe is in place, two (2) ½" diameter stainless steel bolts will be installed 1" from the upstream end perpendicular to each other and through the center of the pipe to act as a trash rack. The trench for the HDPE pipe will be backfilled with a minimum of 2' 6" of INDOT SS flowable backfill over cured low strength mortar and topped with embankment fill and topsoil to match existing grade. The embankment will be mulch and seeded. Riprap will be placed at the HDPE inlet and will match existing grade. Riprap will be placed at the outlet to provide erosion protection. The riprap will extend out 7' in all directions. The existing paved dam crest will also be replaced.

Project Description: The existing bridge carrying Cement Plant Road over Leatherwood Creek will be replaced (Des. No. 2002973). The new structure will be a 3-span prestressed composite concrete I-beam bridge with span lengths approximately 71', 68'-3" and 69' -10.625". The structure will have an out-to-out length of 20'-6" and a clear roadway width of 20'. The spill through abutments will have 3:1 sideslopes armored with class I riprap. The abutments and piers will be skewed approximately 30 degrees. The new approach roads will be constructed to serve the new bridge tapering back to the existing alignment. Approximately 200' of approach work south and north of the new bridge will be needed to tie the new road back into the existing roadway alignment. The existing structure and excess pavement will be completely removed. This project is federally funded.

Project Description: A new residential development will be constructed along the east bank of Wilson Ditch. Floodway construction activities will include a storm water detention basin, an earthen embankment, outfall system, and an excavation area. An approximately 1,200' deep incised, storm water basin will also be constructed. Material excavated from the basin will be used to elevate the building pads located outside of the floodway. An earthen embankment along the streamward side of the detention basin will be approximately 2' high by 1,200' long with 4:1 sideslopes and will have a 4' width. It will be set back approximately 200' from the top of the streambank. The outfall system will be approximately 200' long and will consist of a 200' long 4' wide flat bottom ditch that will terminate at the stream and will match the existing contours of the bank. The excavation area will be approximately 200' long by 600' wide and will be excavated approximately 1'-3' deep to provide for lost floodway fill from the detention basin and provide in excess of a 1:1 ratio of excavation to fill. A total of 6.08 acres in the floodway will be disturbed by the construction.
