February 25 thru March 2 is **National Invasive Species Awareness Week!** It's also Indiana's Invasive Species week. Follow along on <u>Indiana DNR's Facebook page</u> this week as we talk about some of the effects of invasive species in Indiana.

During this week each year, organizations attempt to share information about the impacts, how to prevent the introduction of, and how to control invasive species. While DEPP often uses this week to focus on invasive plants, it's important to remember there are many invasive insects, diseases, and animals that have been introduced to the United States.

Need some suggestions for celebrating Invasive Species Week?

- Now is a great time to check hemlock trees for possible <u>hemlock woolly adelgid</u> infestations or to look for <u>spongy moth</u> or <u>spotted lanternfly</u> egg masses.
- <u>Cooperative Invasive Species Management Areas (CISMAs)</u> are grass roots organizations that
 work on local invasive species projects. Get in touch with your local CISMA and check out their
 next meeting or Weed Wrangle.
- Take a moment to learn something new about invasive species. Check out <u>Purdue's Invasive</u>
 <u>Species YouTube playlist</u> for a great place to start. The North American Invasive Species
 <u>Management Association (NAISMA)</u> is also hosting a <u>series of workshops and seminars</u> this

week.
