The sale has the following conditions:

<b>Buyer will be responsible for gaining access to sale area across private property. This sale is located on approximately 68 acres. Trees are individually marked with red paint, with the exception of one area boundary marked in yellow. There is 1 yard located on this sale. A pre-harvest conference must be attended prior to the start of any logging operations. Operational dozer must be on site at all times during active harvest operations for clean up of skid trails. Buyer will be responsible for purchasing additional stone after the sale is sold.</b>

The timber specified in this document is Certified Wood. Indiana State Forests are certified by both the Sustainable Forestry Initiative (SFI) and the Forest Stewardship Council (FSC). Purchasers of State Forest timber may market state forest timber products as certified if they have the appropriate Chain of Custody certificate.

The FSC Certificate Number for Indiana State Forests is SCS-FM/COC-00099N. The FSC claim is "FSC 100%".

The SFI Certificate Number for Indiana State Forests is NSF-SFIS-6L841-S1.
