21st CCLC is a federally-funded program grant (Title IV-B) awarded to public school districts, charter schools, community-based organizations, public/private organizations, faith-based organizations or a consortium of these organizations, to provide youth a safe environment during non-school hours. This program supports the creation of community learning centers that provide academic enrichment opportunities during non-school hours, particularly for those who attend high-poverty and low-performing schools. The program helps students meet state and local standards in core academic subjects, offers an array of enrichment activities to help their personal development, and provides literacy and other educational services to the families of participants.
