# **Child and Adult Care Food Program Newsletter**

This weekly newsletter from the Indiana Department of Education (IDOE) provides important announcements and updates regarding the U.S. Department of Agriculture's (USDA's) Child and Adult Care Food Program (CACFP). CACFP is a federal program that provides reimbursements for nutritious meals and snacks to eligible children and adults who are enrolled for care at participating child care centers, day care homes, and adult day care centers. CACFP also provides reimbursements for meals served to children and youth participating in afterschool care programs, children residing in emergency shelters, and adults over the age of 60 or living with a disability and enrolled in daycare facilities.
