SAT STC Workshop #1 This workshop will provide an overview of policies, procedures, test administration timelines, available resources, and communication planning prior to spring 2025 SAT testing.	Wednesday, November 13 – Tuesday, November 26	
Submit Off-Site Testing Plans Schools must submit a Smartsheet form to inform College Board and IDOE of their plans to test students off site.	November 2024 – February 2025	
Services for Students with Disabilities (SSD) Coordinator Training SAT Test Coordinators must appoint an SSD Coordinator within SSD Online. The SSD Coordinator will complete this required training to ensure that accommodations are successfully implemented for the SAT.	Thursday, December 5	
Official SAT Practice Webinar This webinar will provide an overview of official SAT practices from Khan Academy and College Board, including coaching tools and resources to help provide students with the best SAT experience.	Thursday, December 12

State-Allowed Accommodations (SAAs) Request Window Schools must request SAAs for any students that require them.	January 9 – February 10, 2025	
Deadline to Submit College Board Approved Accommodation Requests & English Learner (EL) Extended Time Requests  This deadline serves to ensure that accommodations are requested in time to be approved for testing. This includes schools that must submit any requests for students who will require an accommodated paper test. The Extended Time accommodations for EL students must be requested in SSD Online, but do not require approval.	January 13, 2025	
College Board Required Online Test Coordinator & Additional Staff Training Available This training is required for all SAT STCs and proctors. STCs have the option to train proctors in person, or proctors can complete the online training individually.	Week of January 27 – February 24, 2025	
Access to College Board's Test Day Toolkit (TDTK) and State Data Management System (SDMS) Available SAT Test Coordinators will be provided school-level access to TDTK, College Board's digital test administration platform, and SDMS.	Week of February 3, 2025	
SAT STC Workshop #2 This workshop will provide an overview of digital readiness, required online training, testing timelines, available checklists, TDTK, irregularity reports, and post-testing activities.	February 12, 2025	
Digital Readiness Window Opens Students are encouraged to opt in to College Board's Connections feature. SAT Test Coordinators should conduct final digital readiness activities to prepare for spring testing.	Week of February 17, 2025	
Paper Testing Materials Shipments Paper testing materials will be shipped to approved paper-testing schools, schools with students with approved accommodations in SSD Online for paper-testing, or schools with individual students that IDOE approved for paper testing due to special circumstances.	Week of February 17 - March 13, 2025	
SAT Question & Answer (Q&A) Sessions IDOE will host two Q&A sessions for educators to address questions regarding the administration of the Digital SAT School Day prior to the operational testing window.
