CNPweb Program Year (PY) 2025 Application

The August claim deadline of Wednesday, October 30, is quickly approaching. It is important to ensure approval of your application by this date. If your application is not yet approved, please make sure it is in "pending approval" status. Check your email inbox for any unanswered emails from IDOE staff regarding items that need correction for approval of the application. Reach out in the CNPweb help form with questions.

The 2024 AFR is due in CNPweb by **Friday, November 1**. Significant changes have been made to the AFR this year, and a weekly webinar series will walk through changes, required information, errors vs. warnings, helpful resources, and more. IDOE will also offer drop-in help sessions where School and Community Nutrition (SCN) Finance specialists are available to answer any questions. USDA Foods

Use Your USDA Foods

Schools must use their USDA Foods sitting at the state assigned warehouse, Dilgard Frozen Foods or Stanz-Troyers Foodservice and/or the processing companies in order to receive maximum benefit and reduce their school food budget. Non-use of USDA Foods can lead to food and funds loss, waste, improper inventory management, and excess inventory. USDA wants schools to use their USDA Foods in the year allocated. Remember to use carryover pounds first.

Remember to Receipt in FFAVORS

Schools should be receipting their Department of Defense (DoD) produce receipts into the Fresh Fruits and Vegetables Order Receipt System (FFAVORS) within five calendar days after the produce delivery.

New USDA Foods Forecasting Page

IDOE developed a new <u>Forecasting webpage</u> to assist school food authorities (SFAs) with forecasting USDA Foods and consists of processing company commodity calculators, a forecasting video, links to the Food Buying Guide, production record examples, and USDA's Food Cost Analysis Tool.

Recertifying the FDP and USDA Foods

Login to <u>CNPweb</u> and navigate to FDP.

- · Read the update and message screen, then scroll to the bottom and click "continue."
- · Click "Program Year 2025" in the upper-right corner.
- · Go to the applications tab and click the "Edit" link.
- · Verify and/or update the address and contact information.
- · Ensure that a 24-hour access phone number (such as a mobile phone number) is entered.
- · Scroll down to box 29 in the verification section and place a checkmark in the box.
- Click the submit button, and your account should be pending approval.
- IDOE will approve your account if all requirements are met.

If your account has the following message, "You do not currently have a NSLP information sheet for Program Year 2025 in a Pending Approval or Approved status. You must complete the enrollment process for the National School Lunch Program before your FDP information sheet can be Certified and Approved," your school still has tasks that need to be completed under SNP.

USDA Foods Recipes

Use your USDA <u>canned</u> or <u>frozen</u> apple slices for this variation of <u>apple</u> <u>crisp</u>. This recipe must be adjusted to meet serving sizes and meal patterns.

Reminders

Traditional Verification Period Has Begun

Verification samples are based on the number of approved applications on file as of October 1 each year. Sponsors with a 20% or higher non-response rate the previous year are required to conduct standard (error-prone) verification. Review the <u>verification method spreadsheet</u> and find your school to see if this verification is required. Sponsors able to select any method can choose any of the three options, including error-prone verification.
