#### **SUN Bucks Phone Line Closed**

Due to the end of the 2024 SUN Bucks Program, the call center phone line has been closed. Households can still reach out through the <u>SUN Bucks Help Portal</u> with questions or concerns.

As a reminder, funds are expunged 122 days after cards are initially issued to households. For issued cards that did not arrive or for households reporting an incorrect address, the issuance period is unfortunately not able to be extended.

The 2025 SUN Bucks Program will open next spring. To ensure households receive SUN Bucks cards to the correct address next year, please advertise the need for correct address information at the school-level by April 30, 2025.

All DoD FFAVORS external users must have a Login.gov account to access FFAVORS before Monday, September 30, per USDA. Access the Login.gov website and click the "Sign in with LOGIN.GOV" button. If you need assistance, contact the <u>FFAVORS help desk</u>.

#### **DoD Fresh Produce Orders and Receipting**

SFAs placing orders must receipt in FFAVORS within five days of receiving DoD orders.
