WIDA AMS Test Setup Available for Registrations Test setup opens for the ACCESS 2024-2025 test administration in WIDA AMS. Identified ELs not included on the Pre-ID file can be added and registered for ACCESS Online testing. Existing students' demographic data and test registrations can be edited, as needed. Initial Materials Orders Arrive Initial materials arrive in corporations. Initial materials are populated based on Pre-ID data.	Tuesday, January 7, 2025		
Additional Materials Ordering (AMO) Window Opens  AMOs can be submitted in WIDA AMS. AMOs should be placed at the district level. A single, consolidated AMO should be placed if multiple schools within the corporation need additional materials. Inventory initial materials prior to placing an AMO.
