# **Technical Assistance-Notification Error in CNPweb**

Several students identified during the benefit issuance review received a lesser benefit than qualified. Due to a notification error in CNPweb, the SFA was unaware of the increased benefits for these students. The reviewer provided technical assistance onsite regarding how to identify the new changes. The school food service director implemented the new changes on April 4, 2024.

# **Technical Assistance- Revenue vs. Food Cost Ratio**

The nonprogram revenue tool resulted in minimal compliance when comparing the ratio of revenue as compared to the ratio of food costs. Individual a la carte food costs and compared that to the prices to ensure they are at least 2.5 -3 times the raw food cost. Nonprogram revenue must be assessed annually. This serves as a reminder to review nonprogram food costs and price a la carte items accordingly prior to the beginning of the 2024-2025 school year to maintain compliance.

#### **Technical Assistance-Lunch Menu Certification Week**

It was noted that the number of grain ounces served for the lunch menu certification week was almost three times the minimum required amount. For meat/meat alternate ounces, the amount was double the minimum required. The starchy vegetable subgroup was nine times the minimum amount needed. The menu planner should be more conscientious about offering the higher ounce portions and starchy vegetables to help meet a lower sodium and calorie amount.

### Finding: Selling Non-Compliant Smart Snacks During School Hours

Some non-compliant Smart Snack candies and snacks located inside a vending machine were available to students in the school hallway during school hours on the day of the state agency's meal service review. The vending machine was unplugged immediately once staff were notified.

### **Corrective Action:**

Send an email to Canteen notifying them that the SFA participates in the School Nutrition Program and that vending machines with non-complaint drinks, candies, and snacks cannot be available to students during school hours. Define school hours to the distributor. Upload a copy of that email into the review tool and confirm this will be monitored on a regular basis. Next school year, an unannounced follow-up review will be conducted on the vending machines.

# Technical Assistance- Vendor Purchasing Non-Domestic Products Outside of the USA

The state agency field specialist noted broccoli was purchased from Mexico and no letter was on file from the distributor stating it was not available in the USA. While single purchases of broccoli can be supported with a non-domestic substitution, if a letter is obtained that indicates that the vendor cannot supply the requested item for the entire year or other period, the SFA should consider other vendor sources for domestically produced products.
