Finding 9009: SFSP Outreach

Summer Food Service Program (SFSP) outreach to households was not conducted by the SFA. Although the SFA does not operate the SFSP, all program sponsors operating School Nutrition Programs must inform households of the availability of SFSP meals through other sponsors.

Corrective Action:

The Director of Nutritional Services verbally acknowledged that she understood the SFSP outreach requirement and would maintain proof of outreach moving forward. The potential outreach language below can be used to meet the requirement. A copy of outreach conducted in May 2024 was provided as corrective action. **No further corrective action is needed.**

7. Site monitored in first 4 weeks of operation, date, deficiencies/CA?

Finding 9228: The SFA has not monitored this site's Afterschool Snack Program within the first 4 weeks of operation each year.

Afterschool Snack Program (ASSP) monitoring was not completed by the SFA. The first review should be made within the first four weeks of the start of the program. The second review can take place at any other point during the program year.

Corrective Action:

The ASSP monitoring requirements were discussed with the Director of Nutritional Services. She verbally acknowledged that she understood the monitoring expectations moving forward. The review form provided below will be used to monitor the ASSP in PY25 within the first four weeks of operation as well as a second time later in the school year. Copies of the monitoring forms will be maintained in the Director's office. **If fully implemented as agreed upon, no further corrective action is needed.**

1700. ASSP - areas identified requiring TA, CA?

Technical Assistance: ASSP Menu Planning

The Director was provided technical assistance regarding Baked Lays. The Field Specialist explained that while Baked Lays could be sold as a Smart Snack compliant item, they are not a whole-grain chip and could not be menued as a creditable grain component.

Meal Components & Quantities - Rolling Prairie Elementary School (4693)

410. Review Period- planned menu quantities meet the meal pattern requirements

Finding 9076: Planned menus served during review month do not meet portion size/quantity requirements.

Production records were reviewed for the review period to determine whether the portion sizes of meal components from the menu planned and served during the review period, met the minimum meal pattern requirements for the age/grade group(s) being served. One day during the week reviewed, both a fruit juice and a vegetable-based juice were offered as the fruit component choices. Since juice was offered every other day that week, the total juice offered for the week exceeded 50% of fruit choices.

Corrective Action:

The Director of Nutritional Services was provided technical assistance during the onsite visit regarding the crediting of vegetable-based juices. She had credited the vegetable juice as a non-starchy vegetable, not a juice. To correct the issue moving forward, only one type of juice, either fruit juice or vegetable juice, will be offered daily, in addition to another whole-fruit choice daily. **No further corrective action is needed.**
