Technical Assistance - Accurate information on Income Application

When processing income applications, ensure they are completed accurately and are not based on processor's knowledge of the household. For example, if the total number of household members is recorded on the application as 8, the application must show 8 names.

Meal Components & Quantities - St Pius X Catholic School (D164)

402. Day of Review- the minimum daily quantity requirements are met for the age/grade group being served

Finding 9000: No standard measurement used for vegetables

On the day of review, no standard serving size was used to measure vegetables. Staff used their hands to serve most vegetables at the salad bar. Since at least ½ cup fruit or vegetable is required for each reimbursable lunch, with a required planned component of ¾ cup serving for vegetables and ½ cup serving for fruits, ensuring students have at least the minimum serving size is crucial.

Corrective Action:

The SFA will describe their process to ensure all students receive at least 1/2c fruit and/vegetable from the salad bar as corrective action.

402. Day of Review- the minimum daily quantity requirements are met for the age/grade group being served

Technical Assistance - Nutrient Analysis

A nutrient analysis must be completed to ensure the SFA is within meal pattern regulations regarding calories, saturated fat, and sodium. On the day of review, at least 5 meat/meat alternates were offered and students were allowed to select all with their reimbursable meal.

409. Review Period- all required meal components per weekly meal pattern requirements were offered and served to students

Finding 9000: Meal pattern compliance

The menu reviewed was not written to show compliance with meal pattern requirements regarding all components, including milk and vegetable sub-groups. However, after a review of production records, the State Agency confirmed meal pattern compliance. For this reason, no meals were disallowed.

Corrective Action:

The SFA will submit a monthly menu as corrective action, showing all meal pattern requirements are met, including milk and vegetable sub-groups each week.

409. Review Period- all required meal components per weekly meal pattern requirements were offered and served to students

Finding 9000: Standardized Recipes

The SFA did not have standardized recipes for all foods served. Standardized recipes are required for all foods served containing two ingredients or more. Additionally, all standardized recipes must contain crediting.

Corrective Action:

The SFA will develop standardized recipes for all foods containing two ingredients or more and submit two as corrective action.

409. Review Period- all required meal components per weekly meal pattern requirements were offered and served to students

Technical Assistance - Production Records

The production record currently utilized by the SFA is hard to follow. It doesn't contain all the required information and staff must remember to write all required information in blank areas of the form. Best practice would be to use the production record template provided by the State Agency.

General Program Compliance - St Pius X Catholic School (D164)

1409. On-site or off-site storage violations were observed

Finding 9150: Storage violations were observed.

The SFA must ensure that all facilities for the handling, storage, and distribution of purchased and donated foods are properly safeguarded against theft, spoilage, and other loss. Canned goods were observed with dents. Build-up was observed in ice machine.

Corrective Action:

Dented cans were discarded while the SA was on-site and the kitchen staff were in the process of cleaning the ice machine as the SA was completing the on-site review. If the SFA continues to be observant of these and other storage issues, and corrects as needed, no further action is required.
