AMENDED Program Year 2015 (PY15) Workforce Innovation and Opportunity Act
(WIOA) Formula Allocation

This memorandum supersedes the memorandum issued May 21, 2015, announcing the local adult, dislocated worker, and youth allocations for PY15. While the below content is the same as the May memorandum, please see Attachment A for amendments to the allocation amounts for July 1, 2015.

The calculations used to formula allocate the WIOA Title I funds to the local Workforce Development Boards (WDBs) are described in WIOA Sections 128 and 133. While the state applied the 90% hold harmless provision contained in WIOA to adult, dislocated worker, and youth, the United States Department of Labor (USDOL) only applied the hold harmless provision to adult and youth state allocations. WIOA Sec 132(b)(2)(B)(iii) states: "For fiscal year 2016 and each subsequent fiscal year, the secretary shall ensure...that no state shall receive an allotment [for dislocated worker programs] for a fiscal year that is an amount based on 90% of the allotment percentage for the preceding fiscal year." Thus for PY 15, USDOL did not apply the hold harmless to state dislocated worker allocations, which accounts in part for the sharp decline in funding for that program. To help alleviate the impact of the reduction, DWD retained 15% of the dislocated worker funds for state activities (rather than the maximum of 25%).

General Parameters

- Funds are initially available for obligation beginning July 1, 2015; another allocation will be issued October 1, 2015;
- All WIOA Title I cost limitations are allocation-based;
- At a minimum, funds must be 80% obligated at the end of the program year in which the funds were formula allocated (which is June 30, 2016 for PY 2015 allocations);
- Funds must be 100% expended by the end of the program year succeeding the program year in which the funds were formula allocated or be returned to the state (which is June 30, 2017 for PY 2015 WIOA allocations);
- Local administration costs are limited to a maximum of 10 percent.

Transfer Authority

A WDB may transfer up to 100% of the Program Year 2015 Adult and Dislocated Worker allocations and up to 50% of the Program Year 2014 Adult and Dislocated Worker allocations between the two programs. WIOA states that local entities must seek the approval of the Governor to make such transfers. The Governor is giving blanket approval to local entities to transfer at their discretion as long as the funds to be transferred have not already been drawn down or expended. No funds may be transferred to or from the WIA Youth program. NOTE: Please continue to process a grant modification through your fiscal officer for any transfer.

Carry-In

DWD will establish no upper limit on the amount of funds that may be carried in from one year to the next, as long as the 80% obligation rate is met.
