Subject: Rate Changes/Titration

The purpose of this memorandum is to provide communicate the updated billing rates and titration guidance. Please keep in mind, the below Tier Billing designations are separate from the individual recovery residence level designation. If providers have questions, please reach out to Recovery Works via JIRA.

Below is a summary of the upcoming changes:

Recovery Residence Tier Billing

<u>Service</u>	<u>Rate</u>	<u>Unit</u>
Tier 1	\$22	Day
Tier 2A	\$26*	Day
Tier 2B	\$30*	Day
Tier 3 – GOLD STANDARD*	\$34*	Day

TIER 2A

- Room only
- Billing rate **\$26** per day
- **Must accept all forms of medication (including MAT)**

TIER 2B

- Room and Board (consists of room, 1 prepared meal and enough for additional meal)
- Billing Rate **\$30** per day
- **Must accept all forms of medication (including MAT)**

TIER 3 - GOLD

- **Requires written communication from Recovery Works to bill at this level**
- **Objectives included on the Recovery Works website**

Titration



- All recovery residence providers must utilize the Standard Titration schedule. A copy of this titration method can be found at: [Microsoft PowerPoint - Recovery Works Remodel Final](#)
- Participants who return to the same agency are given a 30-day grace period (Recovery Works pays in full for 30 days) upon return, then titration will begin where he/she ended previously.
- Participants who are new to an agency will follow the Standard Titration schedule.

Example: If a participant leaves during month five of titration and returns four months later, they will resume titration at month five after a 30-day grace period.

Treatment Provider New Rate Changes

- ANSA Redetermination (Non-Medicaid/MRO) -RW \$110.91
- Intensive Outpatient Treatment -RW \$186.35 (3 hours = 1 unit)
- Psychiatric Assessment -RW \$42.35 (1/4hr)
- Substance Use Disorder Counseling- Family/Couple Group w/ Member -RW \$14.58 (1/4hr)
- Substance Use Disorder Counseling- Group -RW \$14.58 (1/4hr)
- Clinically Managed High-Intensity Residential Services -RW \$516.07 (per diem)
- Clinically Managed Low-Intensity Residential Services -RW \$180.46 (per diem)
- Telepsychiatry -RW \$18.37 (per 1/4hr)
