

Making family engagement a priority in Indiana early intervention

The Bureau of Child Development Services is committed to ensuring family voices are heard and strengthening the bridge between the state office and families. The families we serve in First Steps have invaluable experiences and insights to share with program leadership. BCDS believes these experiences should be used to shape policy decisions that directly impact our Hoosier families and children.

At the state level, we have an obligation to integrate the family voice within policy and plan to do so by reaching out to families through surveys and one-on-one conversations.

To facilitate open communication and rich discussions, our office will be hosting quarterly family town hall events. First Steps Family Town Halls will give families an opportunity to receive the latest updates on First Steps services, speak directly with the BCDS team, ask questions, and share their experiences so we can better serve children and families throughout Indiana. We also hope the town halls provide a time for First Steps families from across the state to connect with one another.

The next quarterly First Steps Family Town Hall will be held on Thursday, Oct. 24, 2024, at 1 p.m. and 6:30 p.m. Eastern. Registration for the event is required via <u>the online form</u>. We ask that personnel please share the invitation with current First Steps families.

The role of the ICC is to advise and assist the state's early intervention team in developing and maintaining an early intervention system of the highest quality and balancing family-centered services with fiscal responsibility. Its membership is comprised of parents of children with delays and/or disabilities, state agency groups, early intervention service providers, legislators and others. The ICC meetings are open to the public. The next ICC meeting will be hosted in person on **Wednesday, Oct. 9, from 10 a.m. to 1 p.m. EDT**. EIHub updates made this summer

The Bureau of Child Development Services and Public Consulting Group have spent the summer of 2024 hard at work on ElHub improvements!

Both teams have spent over 75 hours in meetings to identify, outline, and prioritize improvements needed to

ElHub. We have reviewed 84 user stories to send to the development team and spent countless hours testing items. We are fully devoted to improving the system to meet the needs of our users and have had three significant system improvement releases in the last several months.

On May 30, a release was pushed to the ElHub Service Logging

module. This release impacted the greatest number of EIHub users and included fixes to the process related to downloading a PDF copy of the provider summary of service form (face-to-face sheet). Our team collected input directly from system users and from those conversations we have created a step-by-step guidance document outlining the process. Once finalized, the document will be sent to all users. The next release occurred on June 5 and was the largest to date. This release was specific to the Case Management module. From development to deployment, this release took nearly one year and included close to 1,000 items! On June 27, there was a release to correct issues found after the previous Case Management release. While the

> latest release did not include all items necessary to replace every paper/ PDF form that we use to document a child's time in First Steps, it was a giant step in the right direction.

Releases to both the Service Logging and Case Management systems relied heavily on testing directly from EIHub end users. It is the goal of the state office to include actual

users of the system in the testing process whenever possible. If you are interested in being an ElHub tester in the future, please <u>submit your information here</u>. We would greatly appreciate your input and may contact you when we have items to test specific to your role. We have a long road ahead of us but have seen significant improvements to the system this summer and will continue to see changes over the next year.

Early Intervention Professional Development System

The Bureau of Child Development Services is pleased to announce our continued partnership with the Early Childhood Center at the Indiana Institute on Disability and Community at Indiana University.

Our new professional development system contract kicked off July 1. It includes the continued development of First Steps onboarding training modules, the national webinar series, and the annual Indiana Early Intervention Conference, which has become a cornerstone of professional development for First Steps personnel, as well as our partners and colleagues across the state. We are also very excited about the creation and implementation of tiered technical assistance to help support early intervention personnel.

BCDS values our partnership with ECC and looks forward to great work to come in the next couple of years as we focus on professional development and support for Indiana's early intervention personnel.

FGRBI: What is caregiver coaching?

Caregiver coaching is an interactive process to promote child's development

During early intervention visits, providers support the caregivers to identify strategies, practice those strategies during visits, and reflect on and problem solve successes and challenges.

Early intervention providers may use a variety of coaching strategies to support families. Family Guided Routines Based Intervention includes two different types of coaching strategies, general coaching strategies which includes information sharing and observation and specific coaching strategies which incorporates direct teaching, demonstration with narration, guided practice, caregiver practice, general and specific feedback, problem-solving and reflection. Check out the <u>FGRBI handout</u>, which further identifies coaching strategies.

Which strategies are you already using? Which strategies feel less familiar? As early intervention providers, we want to individualize not only for the child but also for the learning preferences of the caregiver. Becoming comfortable with the use of multiple coaching strategies will support you in promoting caregiver competence and confidence with the intention of leading to expanded opportunities for the child.
