Year-End Updates

Due in part to the implementation of changes to the NBS TB investigation module this year, there has been a temporary change in the way IDOH is following up on missing data and how TB disease case data will be reported to the Centers for Disease Control and Prevention (CDC) as part of year-end reporting. Thank you for your patience with this change. A return to the standard reporting process is anticipated for next year-end.

Please prioritize completing missing or unknown variables for TB disease cases as this data is due to CDC at the end of January. Contact investigation data will need to be completed during Q1 2024 for 2023 and 2022 TB cases for reporting to CDC.

TB Technical Instructions and Class B Notifications

Updates to the Panel Physician and Civil Surgeon TB Technical Instructions are anticipated to be released in January 2024, with an effective date of Oct. 1, 2024. Additional information will be shared as it becomes available.

If you have received a Class B Notification form recently, you may notice that the form was slightly revised by CDC earlier this quarter. If you have any questions about these revisions, please reach out to a member of the TB Program.

During 2024, the TB Program plans to work on a Class B module for NBS that will aid in improving the Class B reporting process. In addition, training will be developed about this new module and the Class B process in general. We also anticipate adding a Class B reference section to the website.

TB LHD Needs Assessment

Thank you! A 97 percent response rate was achieved for this year's TB local health department (LHD) needs assessment. The TB program greatly appreciates your feedback.

A great need for phlebotomy training was noted with 54 jurisdictions requesting this type of training. The TB program is partnering with Health Care and Education Training (HCET) to hold several phlebotomy training sessions for LHDs during the first half of 2024.

The IDOH Emergency Preparedness division is planning to offer phlebotomy training during the next year as well. [See the website](#) for additional information and to request training.

The needs assessment produced a number of suggested topics for the annual World TB Day Summit and other training opportunities.

Analysis of the data continues and we hope to address more of the needs identified in the upcoming year.

Fall Indiana APIC Conference

The Indiana Association for Professionals in Infection Control held their fall conference in early November in Greenwood. The TB program had a resource table and shared a poster, [Tuberculosis and Infection Prevention Resources](#), at this event. It was a great opportunity to connect with a number of infection preventionists and share TB-related resources.

Local Health Department Symposium

In October, the IDOH LHD Outreach division hosted the Public Health Leadership Symposium for health officers and LHD administrators. Kelly White, TB Program Director, presented *What a LHD Administrator Should Know About TB*. Slides from the presentation are located [on the website](#).

IDOH Long-term Care Conference

The IDOH Long-Term Care (LTC) division held its annual conference in October. This was the first year that the TB Program has a resource table at the event. A new resource was created for this event [Tuberculosis Screening & Testing of Healthcare Personnel](#) in the long-term care setting that was shared along with LTC's [Tuberculosis Assessment & Testing of Long-term Care Residents](#). The table saw a significant amount of traffic and there are plans to attend this event again in the future.



N-95s and FIT Testing

Airborne precautions are used in addition to standard precautions to prevent disease transmission from individuals known or suspected of having infectious TB disease.

All health care personnel should wear a National Institute for Occupational Safety and Health (NIOSH)-certified, **fit-tested**, N95 respirator or higher before entering an area of shared air space and wear at all times while in the area of shared space.

The respirator can be removed just after exiting the area. An N95 respirator can be discarded into the regular trash.



HIPAA Compliance and vDOT/eDOT


- Screening for LTBI

SNTC Patient Fact Sheet Series—Rifampin


