2014 INDIANA MARRIAGE REPORT Preface

The **2014 Indiana Marriage Report** provides a summary of information about the marriages that occurred in the State of Indiana during 2014. The information provided in this report is intended for professionals, students, legislators, and others interested in marriage data.

This report provides 2014 marriages in Indiana by month and day of the week, age, sex, education level, race, ethnicity, marital status, order of marriage, and couple type. Trend data are provided for the number and rate of marriages by county of issuance in Indiana for 2010 through 2014.

Marriage data are collected by the Vital Records Division at the Indiana State Department of Health (ISDH) and by the Indiana Supreme Court, Division of State Court Administration. The tables in this report were prepared by the Data Analysis Team in the Epidemiology Resource Center at the ISDH. For many years, paper copies of marriage licenses were sent to the ISDH and the Vital Records staff entered the data. The online system, INcite, was developed by the Division of State Court Administration for county clerks to create and issue marriage licenses in Indiana. Some of the counties began using the INcite system in 2007.

The 2014 Indiana Marriage Report is the first report to be published since the 2004 Indiana Marriage Report. There was a delay due to changes in the collection of marriage data and difficulties in integrating the new computer databases. Also, some county clerks did not use the INcite system until recently.

Same sex marriage was legal in Indiana from June 25 to June 27, 2014 and then beginning again on October 6, 2014. According to the Division of State Court Administration, during the short period in June and the initial three days in October when same sex marriage was legal, INcite was not programmed for clerks or couples to indicate the sex of each applicant. On October 8, 2014, the categories were changed on the ISDH-approved marriage license forms from "Bride" and "Groom" to "Applicant 1" and "Applicant 2," and fields were added in INcite to indicate the sex of each applicant. County clerks were asked to go back to edit records from June 25 to 27 and October 6 to 8 to reflect the sex of applicants of same sex couples. Some counties did not make changes to their records for that time period before this report was published. The total number of same sex marriages might be higher than the number reported.

Indiana law does not require the couple to marry in the county that issued their license unless they are both non-Indiana residents. In Indiana, the minimum age for marriage is 18. Exceptions to this requirement are provided for those under age 18 if court approval and/or parental consent is obtained.

Currently, Indiana uses the 1977 Office of Management and Budget (OMB) standards for reporting data on race. The 1977 standards are also used by the National Vital Statistics System for national reporting. The relationship between these two OMB standards and the terms used to report race in this report are as follows:

2014 INDIANA MARRIAGE REPORT Highlights

- There were 46,814 marriages that occurred in Indiana in 2014.
- Marriages occurred most frequently in the months of June (6,853 or 14.6%), October (5,699 or 12.2%), September (4,871 or 10.4%), August (4,729 or 10.1%), and May (4,719 or 10.1%). See Table 1.
- More marriages occurred on Saturday (46.8%) and Friday (20.0%) than other days of the week.
 See Table 2.
- More marriages occurred among the white (84.4%) than black (8.1%) and other race (4.6%) population. More marriages occurred among the Non-Hispanic (88.1%) than Hispanic (6.6%) population (who can be members of any race). See Table 3.
- For all marriages, the average age was 33.8 years and the median age was 30.0 years. For males, the average age was 34.8 years and the median age was 31.0 years. For females, the average age was 32.7 years and the median age was 29.0. See Table 4.
- For all marriages by education (highest grade completed), the majority of individuals had less than four years of college (66.6%) compared to those with four or more years of college (24.1%). See Table 5.
- The majority of individuals were never married before (64.2%) compared with being widowed (2.5%), divorced (33.2%), and having an annulment (0.2%). See Table 6.
- For the majority of individuals married in 2014, it was their first marriage (64.2%) compared with a second marriage (24.2%), a third or fourth marriage (10.6%), and a fifth or more marriage (1.0%). See Table 7.
- There were 45,384 marriages to male/female couples (96.9%), 939 marriages to female/female couples (2.0%), and 491 marriages to male/male couples (1.0%). See Table 8.
- In 2014, there were 46,814 marriages that occurred in Indiana for a rate of 14.2 persons per 1,000 population. In 2013, there were 43,539 marriages (13.3 persons per 1,000 population); in 2012, there were 44,717 marriages (13.7 persons per 1,000 population); in 2011, there were 44,228 marriages (13.6 persons per 1,000 population); and in 2010, there were 43,758 marriages (13.5 persons per 1,000 population). 2014 INDIANA MARRIAGE REPORT Glossary of Terms

Age - Age refers to age in years as reported by the applicants on the marriage license. If a birthday occurs between the date of submitting the application form and the date of the marriage ceremony, the age at the time of the actual marriage ceremony may be one year older than that reported on the license application form. The application form is valid for 90 days.

In Indiana, marriages involving persons 15-17 years of age require parental consent and/or court order, depending on the actual age.

Mean Age - The mean age is the arithmetic average of the age for those individuals for whom age was reported.

Median Age - The median age is the age that divides the number

of individuals into two equal groups. For instance, one half of the males are older than their median age, and one half of the females are older than their median age. Because the distribution of age is skewed (not normally distributed or bell-shaped), the

median is a better measure than the mean.

County of Issuance - The county that issued the marriage license. Individuals must obtain a marriage license from the clerk of the circuit court of the county of residence of either of the individuals. If neither of the individuals is a resident of Indiana, they must obtain the marriage license from the clerk of the circuit court of the county in which the marriage is to be solemnized.

Education Level - The education levels reported in these reports reflect the highest grade completed.

Ethnicity - In this report, ethnicity is categorized as Hispanic, Non-Hispanic, and Unknown. Hispanics can be members of any race. Please see Preface for OMB standards regarding ethnicity.

Previous Marital Status - Marital status prior to the marriage is reported for each individual. Individuals are categorized as never married or, if previously married, by how the last marriage ended (death, divorce, or annulment). The number of previous marriages is also reported.

Race - In this report, race is categorized as White, Black, Other, and Unknown. Other means all other races besides white and black. Please see Preface for OMB standards regarding ethnicity.
