
### ADMINISTRATIVE ACTIONS, NOTES, COMMENTS


**PROGRAM CORRECTION** – turf rail is set at 24 feet, not 36 feet.


**RACE 3: Ownership correction** - #10 IMPLODING: Myron Morehouse

**RACE 4: Inquiry** – to review action going into the far turn between #2 PHANTOM RIDE (4<sup>th</sup> place, Keith Asmussen) and #8 STIRDAPOT (8<sup>th</sup> place, Chase Miller). Asmussen guided his horse into an opening between the rail and Miller, the hole narrowed slightly due to STIRDAPOT appearing to shy away from a horse passing him on the outside, causing PHANTOM RIDE to briefly make contact with the rail, and then with STIRDAPOT. Stewards determined that the incident did not affect the running order, so no action was taken.

**RACE 9: Program correction** - #6 SHIRLEY TWO FOUR raced with a flipping halter in her last start, races with one today.
