### ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

**RACE 1: HISA crop violation** – Gregory Romero (1<sup>st</sup> place, #4 SILLY RULES) committed a class 3 violation of 2280(b)(1) by striking his horse eight times. Romero waived his hearing and has been fined \$250 and suspended one-day (June 04).

**RACE 2: Program correction** - #2 CHARLIESLITRDEVIL races with Lasix (L1).

**RACE 2: Superfecta wagering canceled** – scratched down to five runners.


**RACE 4: Ownership correction** - #5 BARB'S VORTEX: Vortex Racing, LLC (Aaron Reed).


**RACE 4: Inquiry** – Jockey Andres Calleja was unseated coming out of the first turn when his mount, #8 Gio's Baby Girl, appeared to clip heels with #5 Barb's Vortex. After reviewing video replay, the Stewards determined that no foul occurred. Calleja and the horse were both uninjured. No action taken.

**RACE 6: Pentafecta and superfecta wagering canceled** – scratched down to five runners.

**RACE 7: Inquiry, objection, disqualification** – to review action near the 3/16 pole. Claim of foul from Jose Ortiz (2<sup>nd</sup> place, #9 SAKE) alleging interference by Jaime Torres (1<sup>st</sup> place, #4 STYLISH SUE) alleging interference in the stretch. Stewards reviewed video replay and spoke with both jockeys and determined that Torres cut off Ortiz, causing him to steady and that the interference likely prevented SAKE from finishing first. STYLISH SUE was disqualified from first and placed second. Both riders were placed on the Movie List for Wednesday.

**RACE 9: Inquiries, disqualifications** - #8 GV BLACK PANTHER (Giovani Vazquez) was disqualified from 3<sup>rd</sup> and placed 6<sup>th</sup> for interference with #9 CHILN, and #2 HES FABULOUS (Fernando Morin) was disqualified from 8<sup>th</sup> and placed last for interference with #1 HF HIDDEN BEACH.
