

House Rule: Recency Requirements for Horseshoe Indianapolis | This will supersede IHRC Regulation 71 IAC 7.5-4-1 as it applies specifically to a horse that hasn't started for two hundred & forty (240) days or more. A horse that hasn't started in the previous 240 days is not eligible to start @ Horseshoe Indianapolis until it has successfully completed a racing soundness examination administered by the Regulatory/Track Veterinarian. If the Regulatory/Track Veterinarian conducting the racing soundness examination finds the results of the examination to be unsatisfactory or inconclusive as to the racing soundness of the horse, the Veterinarian may, @ his/her sole discretion, place the horse on the Veterinarian's List & establish conditions for removal from the list including, but not limited to, laboratory testing of biological samples & an official workout of a specified distance completed within a specified minimum time.
