Race 2 – Inquiry posted on unofficial second place finisher No. 7 PONDA ROCKY for possible violation of the breaking rule at the finish. After reviewing video the judges determined No. 7 PONDA ROCKY did make a break before the finish, was off stride through the finish, and lapped on by another horse. For violation of the breaking rule No. 7 PIONDA ROCKY finished second placed third.

Race 3 - PURE SWAN POWER was first time Lasix. Announcements made via track announcer and TV scroll.

Race 4 – No. 5 VOLO CANCELLATO originally finished fifth placed sixth for violation of the breaking rule after the start; extended break.

Race 6 – Inquiry posted on unofficial second place finish #3 FIFTY DOLLAR NOTE (Wyatt Avenatti) for possible violation of the breaking rule after the start. After reviewing video of the breaking horse the judges determined that driver Avenatti complied with all aspects of the breaking rule and therefore there was no violation. Horse placed as finished.

Race 10 – Inquiry posted on unofficial second place finisher No. 4 SWAN JEWEL (Trace Tetrick) for possible violation of the breaking rule in late stretch through the finish. After reviewing video the judges determined that driver Tetrick complied with the breaking rule. Furthermore, the horse was not lapped on by other horses at the wire. No reason for disqualification and the horse was placed as finished.

Race 11 – Inquiry posted concerning No. 1 LET EM DANCE and whether the horse made the fair start pole. Video confirmed that the horse was inside of the fair start pole when the rest of the field was released. No. 1 LET EM DANCE declared a starter for wagering purposes.
