## ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 1 - No. 6 CC ROCKIN ROSIE (Jordan Ross) originally finished ninth placed tenth for interference to trailing horses in the first before the quarter. Driver Jordan Ross fined \$200.00 for interference causing a placing. Mr. Ross has requested a hearing to discuss the placing and penalty.

Race 3 - Inquiry posted on unofficial third place finisher No. 5 FIFTY TO WIN (Ricky Macomber, Jr.) for possible violation of the breaking rule after the start. After reviewing video of the break the judges determined that Mr. Macomber complied with the breaking rule and therefore there was no reason for disqualification.
