





### ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

**Race 11** - Inquiry posted on unofficial fourth place finisher No. 3 RAYLEN DREW (Brandon Bates) for possible interference to unofficial ninth place finisher No. 9 HELPSPAYTHEBILLS (John DeLong) in the stretch. After reviewing video the judges determined that No. 3 RAYLEN DREW came out into the path of No. 9 HELPSPAYTHEBILLS without sufficient clearance and struck the horse's legs causing it to make a break. For interference No. 3 RAYLEN DREW finished fourth placed ninth. Driver Brandon Bates fined \$200.00 for interference causing a placing.
