





**Race 5** – Superfecta and trifecta wagering on the race cancelled with the field being reduced to four betting interests after scratches.

**Race 9** – Superfecta wagering on the race cancelled with the field scratched down to five betting interests.

**Race 12** – Inquiry posted on unofficial third place finisher No. 7 SWANDERFUL LIFE (Kyle Wilfong) for possible violation of the breaking rule at the start.
