Race 5 – Inquiry posted on unofficial second place finisher No. 2 SENORITA PALEMA (Ake Savanstedt) for possible interference to unofficial sixth place finisher No. 6 GRACEFUL DESIGN (Andrew McCarthy) in the stretch. While close, video showed that the horse was running prior to No. 2 coming out and the two horses never made contact. This was confirmed by driver McCarthy.

Race 8 (cont.) – General inquiry posted looking at an incident that occurred past the quarter. While it first appeared that the confusion started near the front of the field, driver Jordan Ross stated that his horse No. 1 WHISTLE SHOOTER made a break after shying from the No. 2 SILVERSHOE HALIE. No. 1 WHISTLE SHOOTER finished sixth placed ninth for interference to trailing horses while on a break.

Race 11 – No. 4 LA LA LOLA originally finished ninth placed tenth for a pylon violation in the far turn. No penalty to driver John DeLong as the horse as initially taken inside for safety reasons while on a break.

Race 14 – Recall caused by a power surge which caused all four cameras to go down for approximately four minutes.
