






Race 6 – Inquiry posted on unofficial third place finisher No. 4 THIS KIT ROCKS (Joey Putnam) for possible pylon violation in the stretch. Replay showed that No. 4 THIS KIT ROCK was clearly inside two pylons and while inside pylons passed horses. For a pylon violation; gaining an unfair advantage over other horses. No. 4 THIS KIT ROCKS finished third placed seventh. Driver Joey Putnam fined \$200.00.

Race 12 – Recall charged to No. 6 IT'S ACADEMIC (David Miller) for scoring out of position. The fine was waived because the speaker on the starting gate malfunctioned.
