## ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 6 – No. 1 MAN IN THE MIRROR (Mike Peterson) finished eighth placed tenth for violation of the breaking rule in the stretch (extended break)

Brad Ferguson, driver of ninth place finisher No. 6 ROCKY DON'T LET'M, alleged that his horse got interfered with after the start by official fifth place finisher No. 7 GLACIER SPRINGS (Dan Shetler) causing his horse to make a break. The judges had already made the race official when Mr. Ferguson contacted the judges, and he had not filed an objection with the starter. Upon reviewing video of the start the judges where unable to determine if Mr. Shetler was at fault.

Race 10 - Recall charged to No. 1 PREMIER FINE WINE for refusing the gate.

Deshawn Horton, driver of No. 3 LUCKYSTAIR, spoken to and asked to appear before the judges after causing interference to No. 1 PREMIER FINE WINE (Kyle Wilfong) in the stretch. This is Mr. Horton's third major driving violation since being given his "P" license.
