ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 7 - Inquiry posted on race winner No. 4 ZAPPA (Kyle Wilfong) for possible violation of the breaking rule after the start. After reviewing video the judges determined that No. 4 ZAPPA was in violation of the breaking rule for two reasons. 1. Driver Wilfong failed to continuously lose ground while on the break. 2. The horse was off stride for more than 25 strides which in Indiana constitutes an extended break. For violation of the breaking rule No. 4 ZAPPA finished first placed fourth.

Race 8 - Roy Wilson, driver of No. 5 IMALWAYSCLASSY, warned about using too much arm action while whipping.

Race 10 - No. 7 GHOST START was a late scratch after refusing the gate.
