
**ADMINISTRATIVE ACTIONS, NOTES, COMMENTS**

**Race 1** – No. 2 SIMPLY VOLO (Tim Tetrick) originally finished tenth placed eleventh for violation of the breaking rule; extended break.

**Race 5** – Inquiry posted on unofficial fifth place finisher No. 11 FOLSOM PRISON (Jordan Ross) for possible interference to trailing horses past the ¼, entering the backstretch. Video showed that Mr. Ross failed to properly control his horse and ran up on horses in front of him. This caused confusion to trailing horses, including No. 1 RJ'S SUPERFREAK and No. 9 SONNY BLACK to make breaks. Mr. Ross ran up on No. 10 ER GRIFFIN again striking that horse's wheel causing interference No. 4 STRAIGHTSIERRABLUE. For interference to multiple horses, No. 11 FOLSON PRISON finished fifth placed eleventh. Jordan Ross called the decision "crazy". Despite Mr. Ross' protests he was still fined \$200.00.

**Race 10** – No. 8 SUGAR AND SPICE raced without shoes. Announcements made via TV scroll and track announcer. Tim Tetrick, driver of No. 1 SOIREE HANOVER, warned about using too much arm action while whipping in the stretch.

**Race 11** – Recall charged to No. 1 NEWSROOM (David Miller) after that horse made a break and interfered with No. 10 NOBLESVILLE (Ronnie Wrenn, Jr.)  
Bob McClure, driver of No. 4 STORM SHADOW, warned about using too much arm action while whipping in the stretch.
