Race 4 – General inquiry posted looking at multiple breaking horses after the start and in the stretch. After reviewing video the judges determined no horses needed to be placed. Jared Finn, driver of No. 3 IRA WHO, fined \$300.00 for whipping with other than minimal elbow and wrist action in the stretch.

Race 6 – Inquiry posted on unofficial third place finisher No. 5 LADY PANIC (DeShawn Horton) for possible interference to unofficial tenth place finisher No. 3 LAUREN GRACE (Joey Putnam) in mid-stretch. Video appeared to show Mr. Horton come out into the path of No. 3 LAUREN GRACE forcing driver Putnam to alter course and eventually pull the horse off stride. This was confirmed by Mr. Putnam who stated that Mr. Horton did not have enough room to pull in front of his horse. For interference causing a placing No. 3 LADY PANIC finished third placed tenth. DeShawn Horton fined \$200.00.

Race 9 – Claim on No. 5 BELLOWS BINGE voided because the trainer (LeRoy Eicher) who filed the claim was in the paddock without any horses entered and he was observed by the paddock judge feeling the horse's legs in the stall. This is a direct violation of 71 IAC 6-1-1(3), which restricts potential claimants from the paddock. Mr. Eicher was warned not to attempt this again.
