


### ADMINISTRATIVE ACTIONS, NOTES, COMMENTS


**Race 4** - Inquiry posted on unofficial race winner No. 5 I UNDERSTAND (Brandon Bates) for possible interference to No. 1 ITS ROB NOT BOB (Trace Tetrick) in the stretch. After reviewing video of the incident and speaking with driver Tetrick the judges determined that No. 5 drifted into the path of No. 1 I UNDERSTAND causing his driver to grab up and change course. For interference in the stretch No. 5 I UNDERSTAND finished first placed second. Driver Brandon Bates fined \$200.00

**Race 9** - With the scratch of No. 5 BECKON the field was reduced to five betting interests. Per IHRC rules superfecta wagering on the race was cancelled.

**Race 12** - No. 5 SWAN SWAN originally finished seventh placed eighth for interference to trailing horses while on a break before 3/4s.
