Race 2 - Trifecta, superfecta, and show wagering cancelled as scratches reduced the field from to seven to four betting interests.

Administrative Actions, Notes, Comments

- Race 5 No. 3 SWEETNCLASSY (Brad Ferguson) originally finished sixth placed seventh for a pylon violation and interference to trailing horses before 3/4s when the horse began to stop.
- Race 7 Inquiry posted on unofficial fourth place finisher No. 2 MASSIVE DESIRE (Brandon Bates) for possible violation of the breaking rule nearing the finish. Video confirmed that the horse flipped over from the trot into the pace right before the finish and was lapped on by another horse. For violation of the breaking rule No. 2 MASSIVE DESIRE finished fourth placed fifth.
- Race 8 After the race driver LeWayne Miller, driver of No. 6 TRULY UNBELIEVABLE, stated that Brandon Bates, driver of No. 4 IRA WHO, "cussed him out" after the race.
- Race 11 JD Lewis, driver of No. 4 MY UPTOWN WISH, filed an objection against John DeLong driver of No. 2 HOLD MY HALO alleging interference up the backstretch. After reviewing video the judges disallowed the objection finding that no interference occurred.

Race 12 – Inquiry posted on unofficial second place finisher No. 4 NOTORIOUS LUCK (John De Long) for possible pylon violation entering the stretch. Video confirmed that the horse was inside two consecutive pylons and also lapped on at the finish. No. 4 NOTORIOUS LUCK finished second placed third for a pylon violation.
