FAIR CATCH the judges determined that Mr. Luna was inside pylons, came out back onto the track into the path of No. 6 SILVESHOE HALIE. No. violation on the part of No. 6 SILVERSHOE HALLIE and that horse was placed as finished. No. 8 ODDS ON FAIR CATCH finished sixth placed seventh.

Race 8 - No. 5 SEMI FORMAL was a late vet scratch after tying-up in the paddock.

Race 9 – Inquiry posted on unofficial third place finisher No. 3 TELLMEITMATTERS (John DeLong) for possible violation of the breaking rule in the stretch. Video showed that Mr. DeLong failed to lose ground while off stride. For violation of the breaking rule No. 3 TELLMEITMATTERS finished third placed fourth.
