The judges reviewed video and determined that the driver of No. 5 struck one pylon and may have been inside one. The objection was disallowed as the judges determined that the driver of No. 4 CROWN HANOVER did not gain an unfair advantage. Horses placed as finished.

Race 10 – Luke Plano, driver of No. 1 ALWAYS B SWEET, fined \$200.00 for whipping with more than minimal wrist and elbow action in the stretch.
