



### ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

**Race 2** - Objection filed by driver of unofficial third place finisher No. 4 TRUE BLUE LINDY against the driver of unofficial race winner No. 5 CROWN HANOVER for "going inside two pylons". The judges reviewed video and determined that the driver of No. 5 struck one pylon and may have been inside one. The objection was disallowed as the judges determined that the driver of No. 4: CROWN HANOVER did not gain an unfair advantage. Horses placed as finished.

**Race 10** - Luke Plano, driver of No. 1 ALWAYS B SWEET, fined \$200.00 for whipping with more than minimal wrist and elbow action in the stretch.
