ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 4 – Mike Oosting, driver of No. 5 DEAN B HANOVER, fined \$200.00 for using more than minimal wrist and elbow action when whipping in the stretch.

Race 6 - No. 2 GAMBLIN MO had broken equipment after the ¼ and did not finish.

Race 10 – Inquiry posted on unofficial third place finisher No. 4 BILLY CLYDE (John DeLong) for possible pylon violation just exiting the last turn at the top of the stretch. Video showed that while DeLong was inside two pylons and struck another the judges determined that this did not give the horse an unfair advantage as he was in a straight and on the lead. No reason for disqualification and the horse was placed as finished.
