**ADMINISTRATIVE ACTIONS, NOTES, COMMENTS**

Driver Peter Wrenn requested a hearing with the judges stemming from his penalty in race 8 on 10/3/2024 for interference to another horse.

**Race 2** - With the scratch of PONDA DIAMOND the field was reduced to five betting interests. Per IHRC rules, superfecta wagering on the race was cancelled.

**Race 3** - General inquiry looking at breaking horses past the quarter and again in the far turn around 3/4s. In the first turn the judges determined that No. 3 DO ME BEST (Zachary Miller) made a break and caused interference to No. 4 BRANDON'S GAL (Trace Tetrick). NO. 3 DO ME BEST finished sixth placed ninth. The judges determined in the far turn that No. 1 RB'SCATCHMEIFUCAN broke on her own and did not interfere with other horses. Placed seventh as originally finished.

**Race 7** - Inquiry posted on unofficial third place finisher No. 3 PURE CRYSTAL (LeWayne Miller) for possible violation of the breaking rule before the 1/4. Video confirmed that the horse was off stride for more than 25 strides, which in Indiana constitutes an extended break. For violation of the breaking rule No. 3 PURE CRYSTAL finished third placed seventh. With the placing of No. 3 PURE CRYSTAL unofficial fourth place finisher No. 7 GOLD GEM (Jordan Ross) was placed fourth. Inquiry posted on No. 7 GOLD GEM for possible violation of the breaking rule. Like PURE CRYSTAL video confirmed that No. 7 GOLD GEM also made an extended break. For violation of the breaking rule GOLD GEM finished fifth placed fourth placed

seventh. After the placings NO. 5 NATURALLY NAUGHTY finished seventh placed sixth placed fifth. No. 2 JACK MUSCLE finished sixth placed fifth placed fourth. Once official the final top four horses were: 1-8-3-2.

**Race 8** – Inquiry posted concerning No. 4 BEAR'S THE ONE (Kevin Lambright) and if that horse made the fair start pole. Video confirmed that the horse had not passed inside the fair start prior to the rest of the field being released by the starter. No. 4 BEAR'S THE ONE declared a non-starter for wagering purposes and all wagers made on the horse refunded.

**Race 10** - Inquiry posted on unofficial fourth place finisher no. 7 SWAN ALEC (Peter Wrenn) for possible violation of the breaking rule before the ¼. After reviewing video of the break the judges determined that Mr. Wrenn complied with all aspects of the breaking rule and the horse was placed as finished.
