

ADMINISTRATIVE ACTIONS, NOTES, COMMENTS


Race 2 - No. 4 VIRGNES KENNY B was first time Lasix. Announcements made via track announcer and TV scroll. The scratch of No. 3 SMART SCHOONER reduced the field to five betting interests. Per IHRC wagering rules, superfecta wagering on the race was cancelled.

Race 7 - No. 7 HEZA HOT RODDIN was scratched after it was brought to the attention of the judges that the horse raced at Frankfort on October 5, 2024. This line did not make it into the program. Per IHRC rule 71 IAC 7-1-36(a) "Current race lines, including last start, must be available at scratch time or the horse will be scratched."

Race 12 - No. 3 ENCHANTED MISSION was a regular Lasix user.
